Events to celebrate the historic United Nations Declaration on the Rights of Indigenous Peoples next week

Declaration to be considered for adoption by the General Assembly

WHAT: Special indigenous events at the UN to mark the UN Declaration on the Rights of Indigenous Peoples.

HIGHLIGHT: The UN Declaration on the Rights of Indigenous Peoples, a landmark achievement resulting from more than twenty years of efforts, was adopted by the Human Rights Council on 29 June 2006. On 16 and 17 October the Third Committee of the General Assembly will discuss indigenous issues. Coinciding with the occasion, the Secretariat of United Nations Permanent Forum on Indigenous Issues/DSPD/DESA, the Office of the High Commissioner for Human Rights (OHCHR), NGOs and Permanent Missions of Member States to the United Nations will organize several events to highlight the significance of the Declaration.
