April

The month of April witnessed the preparations for the Third Session of the UNPFII at the Secretariat of the Forum. Throughout the month, Secretariat met with the different UN Departments to coordinate preparations for the Third Session, pre-registered participants for numerous Session, prepared background documentation and conference papers, organized events and studied the information provided by Governments organizations of the UN system regarding the implementation of the UNPFII recommendations from previous sessions.

A pre-sessional briefing for Member States, agencies and NGOs was provided by the SPFII on the 28 April.

The Secretariat of the UNPFIL elaborated а database recommendations that displays the recommendations provided by the and classifies according to organization to which the recommendation is addressed, priority, of status implementation, recommendation number and session in which it was produced. The status implementation the of recommendations was prepared by the SPFII in consultation with the UN system, and made available to all the members of the UNPFII. Its launching took place in June!

On 1 April 2004, the Principals of the United Nations Development Group (UNDG) held their annual meeting to decide on the UNDG priorities for the year 2004. Indigenous issues were included as one of the UNDG priorities.

Also during the month of April, the SPFII convened the Inter-Agency Support Group to seek their inputs in order to introduce indigenous issues in а revision of the UNDAF/CCA Guidelines. These guidelines provide the base and orientation for the implementation of development programmes and projects in the field of all the United Nations agencies and programmes.

The SPFII elaborated a contribution to the evaluation of the Indigenous' Peoples Decade, which was submitted on the 12th of April.

May

The month of May was the month of the Third Session of the UNPFII. The Third Session took place from

10 to 21 May 2004 at United Nations Headquarters in New York. The special theme for this session was "Indigenous Women". Participation in the Session included:

- About a thousand NGO, IPO, academic and other civil society representatives, with a very strong participation of indigenous women.
 68 member states and the Holy
- 68 member states and the Holy See.
- Some 33 organizations from the UN system and other intergovernmental entities, which shows a clear growing engagement of the international system with the Permanent Forum.

With regard to the special theme of the Session, "Indigenous Women", the Forum adopted an impressive recommendations, body of enriching international policies on gender and making a valuable contribution to the 10-year review Beijing Conference of the on Women. Twelve pages of recommendations were adopted.

This session, not least through the voices of indigenous women, also brought into focus the grave impact of conflict on indigenous communities and the need for them to have a meaningful voice in conflict resolution and peace building. A number of

recommendations were adopted by the Forum on this subject.

The Forum's lively meetings were complemented by 42 side events, showing the vitality and engagement of your constituencies, indigenous peoples, the UN system, governments and the media. An international funders meeting was held in New York in the context of the Forum's session.

Two pre-sessional training courses were held for indigenous participants to the UNPFII Forum, on the 6 and 10 May respectively at the United Nations Headquarters.

Mr. Turpo, Member of the UNPFII, attended the UNESCO Regional Conference of national commissions, which was held from 3 to 7 May 2004 in Oranjestad, Aruba.

June

After the Third Session of the UNPFII, a post-sessional briefing for the Friends of the Forum and agencies of the UN system about the Third Session was held, and the Secretariat submitted for processing the Report of the Third Session of the Forum.

During the first weeks of June, the SPFII posted all the information, speeches, documents and pictures of the Third Session on the UNPFII's website. You can access

Also during the month of June, the SPFII convened the Task Force on Indigenous Women/ IANWGE, which will work to include the issue of indigenous women in all the work of the United Nations regarding women.

Mr. Jacanamijoy, Member of the UNPFIL. attended the XVII Assembly of the Indiaenous Parliament of America, that took place in Quito, Ecuador, from 2 to 5 June 2004. Mr. Tamang, member of the UNPFII participated in the 20th of session UNFCCC chairpersons of SBI and SBSTA, held in Bonn from 17 to 19 June.

Also during this month, Mr. Jacanamijoy travelled to Santiago, Chile, to participate in the VI General Assembly of the Forum of the Development of Indigenous

Peoples of Latin America and the Caribbean, 21 to 25 June 2004. Ms. Mililani Trask, member of the UNPFII participated in the ECOSOC Panel discussion on mainstreaming gender that was held on 22 June at United Nations Headquarters in New York.

Given the success of Message Stick and the number of requests the SPFII has received to Message Stick in other official UN languages, the SPFII has started producing Message Stick in French, Spanish and Russian.
