Much has happened in these last few months at UNPFII following our Third Session in May. We are very sad to announce the passing of one of our Vice-Chairperson and Permanent Forum member Ms. Njuma Ekundanayo, who was a champion for indigenous peoples and invaluable in pushing our work forward. Ms. Liliane Muzangi Mbela was elected by ECOSOC as a new member from the Democratic Republic of Congo. This period also saw the election of another new member of the UNPFII, Ms. Merike Kokajev from Estonia, thereby completing the mandated number of UNPFII members.

UNPFII members presented and participated in various fora, including the twentieth session of the Subsidiary Bodies for the Implementation of the UN Framework Convention on Climate Change, the International Training Center for Indigenous Peoples, and the third session of the ECOSOC among others. UNPFII was also a partner in the launch of UNDP's Human Development Report 2004, which focused on cultural liberty and made integral references to indigenous peoples.

During this period the Secretariat of the Permanent Forum on Indigenous Issues also enhanced the UNPFII website by launching a database of UNPFII recommendations, which have been organized according to the sessions and status of implementation. The database remains a tool in progress and any feedback or suggestions to improve it would be appreciated.

## COP10 of UNFCCC, indigenous participation

The Twentieth Session of the Subsidiary Bodies for the Implementation (SBI 20) of the United Nations Framework Convention on Climate Change (UNFCCC) took place in Bonn, Germany, from 16 to 25 June 2004. Mr. Tamang attended the sessions in representation of the UN Permanent Forum on Indigenous Issues, where he presented the recommendations of the Forum to the UNFCCC and in a meeting with the Executive Secretary of UNFCCC discussed how the UNPFII and UNFCCC could work together. The meeting also discussed the issue of the participation of indigenous peoples during the Tenth Session of the Conference of the Parties (COP 10) which will be held in Argentina from 6 to 17 December 2004.

According to the SBI 20 session, Draft conclusions proposed by the Chair of the contact group on agenda item 9 d<sup>3</sup>, Effective participation in the Convention process, regarding Participation of indigenous peoples', the SBI considered the recommendations of the Permanent Forum on Indigenous Issues, as well as other requests by indigenous peoples organizations, summarized in document FCCC/SBI/2004/5. The SBI noted that indigenous peoples' organizations have been admitted as observers in accordance with Article 7, paragraph 6, of the Convention and that the secretariat has an officer responsible for liaising with observer organizations, including the indigenous peoples organizations. It also noted that the agendas of the Convention bodies

include items relevant to the concerns of indigenous peoples. The SBI encouraged the indigenous peoples organizations to make full use of the existing bodies and the opportunities currently afforded to them under the Convention.

We deeply mourn the unfortunate passing of one of the distinguished Members and Vice-Chairpersons of the Forum, Mrs. Njuma Ekundanayo, on Tuesday the 6th of July 2004, in Kinshasha, Democratic Republic of Congo. In her, we have lost not only a kind and caring human being, but a strong and fearless voice for the rights of the indigenous peoples all over the world.

## Participation of Mr. Fortunato Turpo in the International Training Center of Indigenous Peoples

The International Training Center of Indigenous Peoples (ITCIP) is based in Nuuk, Greenland. This center provides workshops to indigenous peoples from around the world with the focus on indigenous peoples in the international system.

This year, ITCIP launched a training program from 9 to 24 July in Spanish for indigenous peoples from South and Central America. Mr. Fortunato Turpo was invited to be one of the speakers and he presented the history, mandate and functions of the UN Permanent Forum on Indigenous Issues. Also, he trained the indigenous participants on how to present their recommendations during the annual session of the UNPFII.

### <u>UNDG Programme Group adopted the</u> <u>revised Guidelines for CCA/UNDAF</u>

As part of his 1997 UN reform agenda to make the United Nations an effective institution for world peace and development in the 21st century, the Secretary-General stressed the inter-linkages between peace and security, poverty reduction and sustainable human development, and the promotion and respect for human rights. In response to his call for the United Nations to articulate a coherent vision and strategy for a unified approach towards common development goals at the country level, the Common Country Assessment (CCA) and the United Nations Development Assistance Framework (UNDAF) were adopted as strategic planning tools for the UN system.

These Guidelines are intended to help United Nations Country Teams (UNCTs) to prepare Common Country Assessments (CCAs) and United Nations Development Assistance Frameworks (UNDAFs) as the first steps in the preparation of country programmes and projects supported by UN agencies. Analysis contained in a CCA or a similar national document provides the rationale for UN operations in the country concerned while the UNDAF indicates their link to national priorities (including the MDGs), strategic direction and expected results. The United Nations Development Group has included indigenous issues as one of its 2004 priorities.

During the meeting held on 7 July 2004, the United Nations Development Group (UNDG) adopted the revised Guidelines for Common Country Assessment Assistance and United Nations Assistance Framework (CCA/UNDAF), which include references to indigenous peoples. The UN Country Teams and all UNDG members have been informed about these amendments and are expected

to make them operational. The Secretariat of the Permanent Forum worked close with the Inter-Agency Support Group (IASG) on Indigenous Issues to propose these revisions to the CCA/UNDAF Guidelines.

### Launch of UNDP's Human Development Report 2004 *Cultural Liberty in Today's Diverse World.*

Mr. Magga, Chairperson of the UNPFII, participated at the Global launch of UNDP's Human Development Report 2004 *Cultural Liberty in Today's Diverse World* in Brussels. Mr. Magga's statement appears on the UNPFII web site at:

The Report contains important remarks on indigenous issues such as the following: "Accommodating people's growing demands for their inclusion in society, for respect of their ethnicity, religion, and language, takes more than democracy and equitable growth. Also needed are multicultural policies that recognize differences, champion diversity and promote cultural freedoms, so that all people can choose to speak their language, practice their religion, and participate in shaping their culture—so that all people can choose to be who they are." Also, on the occasion of launch of the Human Development Report 2004, Mr. Parshuram Tamang was invited to deliver a statement in Kathmandu, Nepal. He pointed out that cultural diversity is a common heritage of humankind, which has to be recognized and affirmed for the benefit of the present and future generation. In addition to these remarks, he gave an overview of the status of cultural diversity in the world, the relation of the United Nations

system and cultural diversity, the collaboration between the UNPFII and UNDP, and the specific situation of Nepal with respect to cultural diversity. ## Presentation of the Third Session Report to ECOSOC

Mr. Ole Henrik Magga, Chairperson of the UNPFIL, came to New York to present the Report of the Third Session to the Economic and Social Council and also meet with the chairpersons of the Functional Commissions of ECOCOC and the ECOSOC Bureau to strengthen methods of work and collaboration with the Council. During the meetings he expressed satisfaction to take part in these consultations as it is the UNPFII's mandate to promote coordination and integration/mainstreaming of indigenous issues in the UN system. "It is therefore crucial for me, for us, to be in dialogue with the other subsidiary bodies of the Council and explore how we, together, can help improve the lives of the 370 million indigenous people around the world, one of the most marginalized parts of humanity," said Mr. Magga.

Mr. Magga, also suggested some practical recommendations that will hopefully enhance collaboration among functional commissions:

- A system should be established so that the secretariats of the functional commissions regularly transmit to other commissions, including the UNPFII, multi-year programmes of work and agendas of future sessions;
- Joint meetings of Bureau and secretariats of functional commissions should be instituted,

and budgetary provisions should be made from the regular budget to that effect; such meetings should discuss coordination and how to promote multi-disciplinary approaches on subjects of common concern, including indigenous issues; and

 Commissions, through their secretariats, should distribute to the other commissions resolutions and recommendations of special relevance to each commission.

At its 48th plenary meeting, on 22 July 2004, the Economic and Social Council took note of Commission on Human Rights resolution 2004/58 of 20 April 2004/289 and endorsed the Commission's recommendation that the Working Group be authorized to meet for five working days prior to the fifty-sixth session of the Subcommission on the Promotion and Protection of Human Rights.

## Proposal for a second international decade of the world's indigenous people

### International Day of the World's Indigenous People

In 1994, the General Assembly decided that the International Day of the World's Indigenous People shall be observed on 9 August every year during the International Decade of the World's Indigenous People (Resolution 49/214 of 23 December). The date marks the day of the first meeting, in 1982, of the UN Working Group on Indigenous Populations of the Subcommission on the Promotion and Protection of Human Rights.

The UN General Assembly had proclaimed 1993 the International Year of the World's Indigenous People, and the same year, the Assembly proclaimed the International Decade of the World's Indigenous People, starting on 10 December 1994 (Resolution 48/163). The goal of the Decade is to strengthen international cooperation for solving problems faced by indigenous people in such areas as human rights, the environment, development, education and health.

The program at the United Nations
Headquarters in New York this year included
statements of the UN Secretary-General, the
Chairperson of the UN Permanent Forum
and others as well as various indigenous
cultural presentations. The program was
organized by the Secretariat of the
Permanent Forum on Indigenous Issues in
cooperation with the Department of Public
Information and the NGO Committee on the
International Decade of the World's
Indigenous Peoples.

The Fourth World Finno-Ugric Peoples'
Congress was held in Tallinn, Estonia, from
15 to 19 of August 2004. During the
Congress the members of the UNPFII were
asked by the members of the Youth
Association of the Finno-Ugric Peoples to
have a meeting with the most active
members and participants of this youth
organization. At that meeting indigenous
peoples rights protection issues in the UN
system were discussed.

At the request of the Organizing Committee of the IV World Finno-Ugric Peoples' Congress, Ms. Strogalschikova prepared a special presentation that was given at the Congress<sup>4</sup>. The presentation may be viewed at the website

Ms. Strogalschikova was elected as a Chairperson of the Editorial Commission to prepare the Resolution of the IV World Finno-Ugric Peoples' Congress, which was adopted at the plenary meeting on the 19th of August. UNICEF organized regional meeting on the Programme of indigenous children in Latin America, held in Panama. Mr. Nils Kastberg, UNICEF Regional Director, Mr. Marcos Matias as well other indigenous representatives from Guatemala, Ecuador and Mexico attended this important meeting.

Among other things, they discussed the orientation of a new approach of UNICEF's work with indigenous children and the advancement of the recommendations made by the UNPFII. During this meeting, UNICEF also announced the constitution of an Advisory Group of Indigenous Leaders on indigenous youth and children in Latin America<sup>5</sup>. The result of this meeting will be presented at the Iberoamerica Summit, which will be held from 18 to 20 November 2004 in San Jose, Costa Rica.

## Cooperation between the SPFII and Statistics Division - DESA

The Secretariat of the UNPFII is working with the United Nations Statistics Division (UNSD) on promoting the inclusion of indigenous peoples in national statistics and data disaggregation.

### Task Force on Indigenous Women of the Inter-Agency Network on Women and Gender Equality

The Task Force on Indigenous Women was convened by the secretariat of the UNPFII on 11 June 2004 and the members of the Task Force are UNIFEM, FAO, OSAGI, DAW/DESA, SPFII/DSPD/DESA, ILO, UNDP, OHCHR, ESCAP, ECA and UNICEF. However, as the work develops, the Task Force will be calling upon other agencies to contribute.

The Task Force had before it the recommendations of the UN Permanent Forum on Indigenous Issues at its Third (May 2004) Session, which had Indigenous Women as its special theme. These recommendations drew from the submissions of indigenous women's preparatory meetings in Africa, Asia and Latin America, a panel on the contribution of indigenous women to conflict prevention and peace-building held during the March 2004 session of the Commission on the Status of Women, a high-level panel on indigenous women that opened the Permanent Forum's session, as well as rich discussions during the whole Third Session of the Forum.

The Terms of Reference were adopted by the Task Force on Indigenous Women in September and contain the goals and objectives of the Task Force in the short, medium and long-term. After the adoption of its terms of reference the Task Force met on 28 September to make operational its short-term work plan that will be accomplished by February 2005. The Task Force will report to the IANWGE at its February 2005 meeting.
