Welcome to MESSAGE STICK<sup>1</sup>, the newsletter that highlights the activities undertaken by the United Nations Permanent Forum on Indigenous Issues (UNPFII) as well as its Secretariat for the period from April to August 2008.

### The Seventh Session of the Permanent Forum on Indigenous Issues

The Seventh Session of the Permanent Forum was held at United Nations Headquarters in New York, 21 April to 2 May 2008.



This year's session was memorable in many ways. The Session was held a month earlier than usual, in order not to clash with the 9<sup>th</sup> Conference of Parties of the Convention on Biological Diversity. Attending the seventh session were 11 newly appointed expert Members of the Forum in addition to 4 other members who were nominated for a second three year term. This was also the final session of Mrs. Qin Xiaomei, the Permanent Forum member from China, who will be succeeded by another Forum Member on 1 January 2009.

The Seventh Session also marked the final participation of. Mr. Rodolfo Stavenhagen as the Special Rapporteur on the situation of human rights and fundamental freedoms of indigenous people, who after serving two three-year terms has been succeeded by Mr. James Anaya, the first indigenous person to hold the post.



A Message Stick is a traditional Australian Aboriginal method of correspondence whereby runners would deliver messages carved in symbols on a piece of wood to inform other indigenous peoples of upcoming events.

The seventh session was also attended by President Evo Morales Ayma of Bolivia, the first head of State to address the Permanent Forum, drawing rapturous applause, somewhat unusual for UN meetings.



After President Morales had completed his speech, it was down to business for the Forum attendees. This year's theme was Climate Change and the discussions brought up a wealth of issues from all corners of the world. In addition to the formal meetings of the Forum a total of 61 side events were organized by indigenous peoples' organizations, NGOs, UN agencies and states. All of these formal and informal meetings informed the discussions of the members of the forum and directly or indirectly influenced the outcome of the session, which is contained in the Report on the Seventh Session.

On the last day of the seventh session, some participants expressed their concerns over some of the recommendations of the Forum. At the heart of the concerns was a first draft of recommendations concerning the World Bank's Forest Carbon Partnership Facility and BioCarbon Fund and the policy debates on reducing emissions from deforestation and ecosystem degradation (REDD). These participants were advocating more critical language on these initiatives. The final version of the Permanent Forum recommendations had indeed taken these concerns into consideration, even if the Forum did not explicitly condemn these policies. The Forum did state that "...the current framework for REDD is not supported by most indigenous peoples... In order to

directly benefit indigenous peoples, new proposals for avoided deforestation or reduced emissions from deforestation must address the need for global and national policy reforms and be guided by the United Nations Declaration on the Rights of Indigenous Peoples, respecting rights to land, territories and resources; and the rights of self determination and the free, prior and informed consent of the indigenous peoples concerned." <sup>2</sup>

## Expert Mechanism on the Rights of Indigenous Peoples

The Expert Mechanism on the Rights of Indigenous Peoples will hold its first session from 1 to 3 October 2008 at the United Nations Office in Geneva. Registration is now open online. For further information, see the accreditation page on the OHCHR website.

The Expert Mechanism on the Rights of Indigenous Peoples has been established by the Human Rights Council, as a successor body of the Working Group on Indigenous Populations which was under the now defunct Human Rights Commission. The Expert Mechanism is a

subsidiary expert mechanism of the Human Rights Council established to assist the Council in providing thematic expertise on the rights of indigenous peoples, focusing mainly on studies and research-based advice. The Expert Mechanism may also suggest proposals to the Council for its consideration and approval.

The Human Rights Council has appointed five experts, who will serve for a three-year period and may be re-elected for one additional period. For its first session it will meet for three days on 1-3 October, 2008 and thereafter for up to five days, and these sessions may be a combination of open and private meetings.

In addition, the Special Rapporteur on the situation of human rights and fundamental freedoms of indigenous people and a member of the Permanent Forum shall be invited to attend and contribute to the annual meeting.

The meeting shall also be open to the participation, as observers of:

- United Nations mechanisms, bodies and specialized agencies, funds and programmes
- Intergovernmental organizations, regional organizations and mechanisms in the field of human rights
- National human rights institutions and other relevant national bodies
- Academics and experts on indigenous issues
- Non-governmental organizations in consultative status with the Economic and Social Council
- Indigenous peoples 'oganizations

### Resource Kit on Indigenous Peoples' Issues

The Secretariat of the Permanent Forum, in cooperation with ILO, UNICEF, UNDP, UNFPA and SCBD has published the Resource Kit on Indigenous Peoples Issues. The Kit is principally addressed to UN Country Teams (UNCTs), and other development agents, providing them with guidance as to how to engage with indigenous peoples and include their perspectives in development processes. The Resource Kit provides information on indigenous issues through practical examples and how to engage indigenous peoples effectively in development processes, including Common Country Assessments/United Nations Development Assistance Framework (CCA/UNDAF), MDG monitoring, PRSP and others. It should also help UNCTs implement the UNDG guidelines and the recommendations of the Permanent Forum in addition to serving as a tool that enhances and strengthens the role of UNCTs in integrating indigenous issues to the UN system's work at the country level.

Finally, the Resource Kit includes a thorough, if not exhaustive overview of international agreements and legal frameworks that deal directly or indirectly with indigenous issues as well as international mechanisms that specifically target indigenous peoples.

# Trust Fund of the Second Decade of the World's Indigenous People

The Trust Fund for the Second Decade was established to promote, support and implement the objectives of the Decade, giving priority to projects concerning the main areas of the Second Decade: culture, education, health, human rights, the environment and social and economic development.

Indigenous organizations or organizations working for indigenous peoples can apply for small grants from the Trust Fund. Guidelines to applicants for the Fund are available below. The Fund is mainly used for small grants projects with a budget for up to 10,000 US\$ covering one year's expenses.

2009 Call for Proposals

Applications for Trust Fund grants will be accepted between 20 August 2008 and 1 November 2008. Applications are to be submitted to: indigenousfund@un.org during this time period.

All applicants must submit their project proposals in accordance with the Trust Fund Grant Application Instructions, and must also submit a proposal summary sheet, in conformity with the instructions for filling out the summary sheet. Applicants should also review the Funding Guidelines for Activities Relating to the United Nations Second Decade of the World's Indigenous People, which were amended in July 2008.

# International Day of the World's Indigenous People

The International Day of the World's Indigenous People was observed at UN Headquarters on Friday 8 August 2008, given that this year, the International Day was on a Saturday. The theme of this year's observance at UNHQ was conciliation and reconciliation between indigenous peoples and states. This theme was timely given recent events at both national and international levels.



The issue of conciliation/reconciliation raises a number of important issues and many of them were tackled by a panel that was composed of *Gert Rosenthal*, Permanent Representative of Guatemala to the United Nations, *Henri Paul Normandin*, Deputy Permanent Representative of Canada to the United Nations, *Andrew Goledzinowsk*i, Deputy Permanent Representative of Australia to the United Nations, *Marcie Mersky*, Liaison Officer with the United Nations Department of Political Affairs, *Chief Oren Lyons*, Faithkeeper, Turtle Clan, Onondaga Nation, Member of Grand Council of Chiefs of the Haudenosaunee and *Barbara James Snyder* of the Washoe-Paiute Nation.



Prior to the panel, the messages of the Secretary General, the Under-Secretary General for Economic and Social Affairs and the Chairperson of the Permanent Forum were all delivered to a close to fully packed Dag Hammarskjöld Library Auditorium. Furthermore, a most memorable performance was presented by the Hālau i Ka Wēkiu school from Hawaii.

In addition to the SPFII organized observance, the Permanent Mission of Australia to the United Nations organized a film screening, showing *The Apology* chronicling the historic apology of the Government of Australia to the

Aboriginal and Torres Strait Islander peoples of Australia, and in particular to the "stolen generation" people who were forcibly removed from their families, as children as part of the policy of assimilation that lasted until the 1970s.

The workshop focused on strengthening coordination between indigenous peoples and the government in relation to climate change, develop a strategy for participation and follow-up for national and international climate change processes, provide information to indigenous peoples about the REDD mechanism and to identify potential avenues for indigenous peoples' participation within REDD.
