Ninth Session of the Permanent Forum

The ninth session of the Permanent Forum took place in New York at UN Headquarters from 19-30 April 2010. The Ninth Session was memorable for a number of reasons, including the announcement by the Government of New Zealand of its endorsement of the United Nations Declaration on the Rights of Indigenous Peoples and the participation of Ban Ki-Moon, Secretary-General of the United Nations.

The Ninth session was also affected by the renovations of UN Headquarters, which made the organization of side events more difficult and also contributed to a decreased participation of indigenous peoples at the session. The good news is that this is only a temporary situation, and within two to three years the Permanent Forum sessions will take place in an improved and modernized UN which will be better suited to serve the needs of large meetings, such as the Permanent Forum Sessions. It is expected that the renovated Conference Building,

where previous session of the Forum have taken place, will be opened in early 2012².

Development with Culture and Identity

The general theme of the ninth session was Indigenous peoples: Development with culture and identity; articles 3 and 32 of the United Nations Declaration on the Rights of Indigenous Peoples. A great number of participants spoke on the issue and based on these inputs, the Permanent adopted 29 recommendations Forum related specifically to the theme. The recommendations reflect that it fundamental for indigenous peoples to preserve and develop their cultures and ways of life. Therefore, development for indigenous peoples is closely linked to many aspects of their lives, from education and indigenous languages, to health, to respect for traditional knowledge and traditional ways of living. The visions of indigenous peoples about well-being and development need to be heard by States, through and indigenous peoples themselves must participate effectively in development processes.

Regional focus on North America

This year's regional focus was on North America where representatives of Canada and the United States participated as well as representatives from indigenous organizations. One of the highlights from this year's session was the announcement from the United States that it would start a process of examining its position on the Declaration on the Rights of Indigenous Peoples with a view to its endorsement. A similar statement had been made by Canada in March.

Human rights

Human rights continue to be a major issue at each Forum session and this year was no exception. The Forum held a dialogue with James Anaya, the Special Rapporteur on situation of human rights and of indigenous fundamental freedoms peoples as well as Janine Lasimbang, the Chairperson of the Expert Mechanism on the Rights of Indigenous Peoples. During this dialogue Mr. Anaya and Ms. Lasimbang discussed the work of their respective mandates over the past year. Mr Anaya also emphasized the importance indigenous peoples' self determination in relation to the theme of development with culture and identity.

The Permanent Forum also conducted dialogues with the Governments of Bolivia and Paraguay. The dialogues were a follow-up to the recommendations that the Permanent Forum made following its 2009 visit to the Chaco region of the two countries, to investigate allegations of forced labour and servitude of the Guaraní people. The dialogue with the two Governments, in which representatives of indigenous peoples and the UN system participated, was fruitful and resulted in a number of recommendations by the Forum on how to address the serious situation of indigenous people impacted by froced labour practices in the Chaco region. is the first time the Permanent Forum has held such an in-depth dialogue with Governments.

Half day session on indigenous peoples and forests

A panel was held composed of Permanent Forum members, the Director of the Secretariat of the UN Forum on Forests, indigenous experts and the representative of Brazil. Amongst the issues raised were that conservation initiatives frequently lead displacement of indigenous communities, due to the misconception that the only way to conserve forests is to remove all humans from the forests. Indigenous peoples' sustainable management of their forests was also discussed, as well as the need for governments to recognise indigenous peoples' right to manage their own lands. Forum adopted some recommendations on forests and indigenous peoples that will be submitted to the UN Forum on Forests in early 2011. The year 2011 is the International Year of Forests. Given the importance of forests for indigenous peoples, the Forum decided to hold an international expert meeting next January on this topic.

The report of the Ninth Session will be available in all six UN languages in late

June on the UNPFII website.³ The tenth session will take place in New York at UN Headquarters on 16-27 May 2011.

International Expert Group Meeting: Indigenous Children and Youth in Detention, Custody, Foster-Care and Adoption

4-5 March 2010

Tsleil Waututh Community Centre, North Vancouver, British Columbia, Canada The meeting, sponsored by the First Nations Summit and the Interim First Nations Child and Family Wellness Council and co-sponsored by the Secretariat of the Permanent Forum on Indigenous Issues, focused on indigenous children and youth in state custody. Participants of the meeting explored contemporary removal of indigenous children from families and communities as a result of past government policies to promote assimilation, including policies on boarding and residential schools. They also looked at the vastly disproportionate rates of indigenous children and youth currently incarcerated or under punitive detention; as well as the disproportionate numbers of indigenous children in foster care and adoption programs. The meeting made a number of recommendations to the Permanent Forum, the UN system and Governments. The full list of the recommendations is contained in the report of the meeting, which was submitted to the ninth session of the Permanent Forum in April 2010.4

International Expert Group Meeting Indigenous Peoples: Development with Culture and Identity: Articles 3 and 32 of the United Nations Declaration on the Rights of Indigenous Peoples

Organized by SPFII, the aim of the meeting was to analyze enshrined human rights within international standards and policies

and how these contribute to indigenous peoples' concept of development with culture and identity. The expert group meeting also drew attention to the various development concepts and practices and their impact on indigenous peoples' livelihoods, communities, cultural practices, lands and natural resources. It also identified options and further plans to build the necessary conditions for development such as empowering and strengthening indigenous peoples' organizations and governance systems. The results and recommendations of the EGM are contained in the report of the meeting which was submitted to the Ninth Session of the Permanent Forum.⁵

Visit of Members of the Permanent Forum to Colombia

6-9 July, 2010

During the ninth session of the Permanent Forum on, the Government of Colombia announced that it would invite Members of the Permanent Forum to visit Colombia. On 10 May 2010, the President of the Permanent Forum on Indigenous Issues, Mr. Carlos Mamani, received a formal

letter extending an invitation to the Permanent Forum to observe the situation of the indigenous peoples in Colombia in general, with a particular focus on the situation of the Awa peoples. On the basis of this invitation, members of the Permanent Forum will undertake a mission to Colombia in July 2010.

Third Session of the Expert Mechanism on the Rights of Indigenous Peoples

12-16 July, Geneva

The third session of EMRIP will include a presentation by the Expert Mechanism of the draft progress report on the study on indigenous peoples and the right to participate in decision-making. The third session will also focus on good practices that highlight how the Declaration on the Rights on Indigenous Peoples can be used to promote the rights of indigenous peoples. Furthermore, the Special Rapporteur will hold individual meetings with representatives of indigenous peoples and organizations. More information is available on the Expert Mechanism page here:
