The recommendation to review legislation, policies and programmes for indigenous people.

Government set up a Task Force to review the impact of the Remote Area Development Programme on the livelihoods of remote area communities. Recommendations of the Task Force were approved by Cabinet in September 2010. The recommendations were based on the expressed aspirations of remote area dwellers who are mostly of the San/Basarwa ethnic groups.

Please provide a brief account of some of your Governments' efforts regarding indigenous peoples and the Millennium Development Goals?

Q2

In the area of Poverty Reduction, Government has made it possible for the San/Basarwa and other remote area dwellers to access Progammes such as LIMID, ISPAAD and a livestock Scheme where some communal cattle farms have proved viable.

The remote area communities also benefit from Ipelegeng (Drought Relief Programme). Remote area dwellers also benefit from the Self-Help Housing Scheme as well as the Destitute Shelter Programme.
