INFORMATION NOTE FROM THE CHAIRMAN OF CSD-13 Updated 10 April 2005

The thirteenth session of the Commission on Sustainable Development (CSD-13) will be the first "Policy Session" under the Commission's new work cycle, and the focus will be on water, sanitation and human settlements. The mandate of CSD-13 is to build on the progress made during the "review session" at CSD-12 and to adopt policy decisions that would enable the implementation of practical measures and options related to the three thematic areas. The main aim of CSD-13 therefore is to mobilize action by all stakeholders at all levels for the further implementation of Agenda 21 and the Johannesburg Plan of Implementation (JPOI).

The purpose of this information note is to provide a detailed outline of the organization of work for the Intergovernmental Preparatory Meeting (28 February – 4 March, 2005) and the Policy Session (11-22 April, 2005) of CSD-13. The note will also provide information on the session's processes and the related outputs, which are intended to enhance participation by all stakeholders.

Intergovernmental Preparatory Meeting (IPM): Drawing on the obstacles, lessons learned and best practices, identified and discussed at CSD-12, three Secretary General's Reports addressing each of the thematic areas will be submitted for consideration by the IPM. Each report will also include a number of policy options and possible actions aimed at expediting implementation. I anticipate that this wide range of policy options and possible actions will be vigorously discussed and considered by the IPM.

At the conclusion of the IPM, a "Chair's text," based on the discussions of the meeting, will be prepared and distributed. The goal of this text is to prepare and inform the subsequent discussions for CSD-13's Policy Session in April.

It is well understood that implementation efforts are best undertaken at the local, national, sub-regional or regional levels and that there are no "one-size-fits-all solutions". In preparation for the Policy Session of CSD-13, I therefore strongly encourage all countries to consider the range of policy options and practical actions that will be contained in the Chair's text, with a view to determining which ones are likely to be most relevant and applicable to their national, sub-regional and regional needs and circumstances.

CSD-13 Policy Session: Regional views, implementation measures and efforts are critical. In order to ensure that effective policy decisions are adopted at CSD-13, the global community needs not only to get a clear picture of the practical measures and options which countries intend to take, but also to concretely identify those measures and options that require concerted global and/regional efforts. With this in mind, CSD-13 will allocate adequate time for the *Regional Perspectives Session* on 11 April, 2005.

A <u>summary of regionally-focused policy options and practical measures</u> will then be compiled that will aim to be as inclusive as possible and will reflect the discussions at the regional perspective sessions. This summary will incorporate policy options and practical measures that respond to regionally identified needs and constraints, including proven options, measures and initiatives that have the potential to be scaled-up and/or replicated.

In addition to the discussions on regional perspectives, there will also be a series of *Interactive Discussions* on 12 and 13 April. These discussions are intended to complement the discussions on regional perspectives, but will seek to emphasize the practical measures and policy options requiring concerted global and/or regional efforts.

On the basis of these discussions, I will prepare and subsequently circulate <u>draft elements of concise policy decisions on practical measures and options</u>. These draft elements, **which are intended for negotiation by delegations**, will focus on those actions and measures that identify a practical way forward.

Other Outputs: Throughout CSD-13, I will be inviting all implementation actors to announce any voluntary commitments to mobilize further international or regional action aimed at expediting implementation of Agenda 21 and the JPOI. Any such commitments, whether raised during the officials' level segment of the session or during the High Level Segment, will be compiled and posted on the CSD Secretariat's website and will form the basis of a "living" document that identifies continued efforts to implement the three thematic areas beyond CSD-13.

The Bureau and I will continue to provide regular updates on the aspects of the organization of work in due course.

Let me conclude by reiterating my pledge to work closely with all stakeholders to ensure that we collectively achieve the aspirations for the Commission that were clearly articulated at the World Summit on Sustainable Development.

Chair's explanatory notes for changes to the CSD-13 Organization of Work

Monday 11 April

Regional perspectives sessions have been collapsed into one session on Monday afternoon, 11 April. The purpose of this session is to hear and discuss the following:

- which policy options and possible actions, emerging from the IPM, are most applicable to your region;
- which practical measures do countries in their region intend to take to advance progress;
- which options or measures might require additional global or regional effort to implement; and
- what mechanisms or arrangements might help to expedite these.

Tuesday 12 April – Wednesday 13 April

Twelve hours of interactive discussion have been allotted to water and sanitation (6) and human settlements (6). Policy options and practical measures, captured in the Chair's IPM text, have been clustered under a series of broad topics; for example, under Water, one of the topics is, integrated water resources management (IWRM); and under Human Settlements, another is, access to housing and public services. The intent of these interactive discussions, which will be led-off by panels of UN agencies and IGOs, is to focus on those policy options and practical measures that require concerted global effort. The discussions should include consideration of all cross-cutting issues.

Wednesday 13 April:

The morning session includes a discussion of water and sanitation follow-up. There is no equivalent discussion for human settlements as an international home for follow-up for this theme is more obvious.

To ensure that all aspects of interlinkages are discussed, there will now be two sessions devoted to this, one focusing on interlinkages among the 3 themes, and the second, focusing on interlinkages among the 3 themes, along with consideration of all cross-cutting issues. These discussions have been moved up to Wednesday afternoon.

Thursday 14 April:

The interactive discussion with <u>Major Groups</u> has been deleted in favour of integrating Major Groups' inputs throughout the interactive discussions in the previous three days. The Intergovernmental Preparatory Meeting (IPM) made significant progress in ensuring a more direct and substantive involvement of Major Groups in the work of the Commission, as called for in the Johannesburg Plan of Implementation and spelled out in the CSD-11 decision. This was reflected in their substantial integration into the interactive discussions during the IPM. Thus, the Bureau agreed that such integration should continue during CSD-13.

The distribution of the Chair's draft elements for negotiation has been moved up from Friday morning to 9:00 a.m. on Thursday 14 April to give delegations more time to study the Chairs' draft. There will be no plenary meetings on Thursday.

Friday 15 April:

Consideration of the Chair's draft elements for negotiation will commence on Friday morning, 15 April.

Monday 18 April on interlinkages among the 3 themes:

The Finance Ministers panel has been expanded to a panel of Finance and Development Cooperation Ministers.

Other:

Re the balance in the case studies in User-friendly matrix based on Chair's IPM text: the case studies referenced in the matrix are only meant to be illustrative.

A more comprehensive set of case studies, which governments are invited to submit, will be prepared for posting on the CSD website. To help in this regard, the CSD Secretariat will be posting a user-friendly template for reporting on both the case studies and the voluntary commitments.

Updated Organization of Work for the Thirteenth Session of the Commission on Sustainable Development 7 April 2005

OVERVIEW

By the decision of CSD-11, subsequently approved by ECOSOC, the policy session of CSD in the two-year implementation cycle will take policy decisions on practical measures and options to expedite implementation in the relevant thematic areas. CSD-13, with the thematic focus of water, sanitation and human settlements, convened its Intergovernmental Preparatory Meeting from 28 February – 4 March 2005 and will convene its Policy Session from 11 April to 22 April 2005 at the United Nations Headquarters in New York.

In accordance with the decision of CSD-11, the Policy Session will take account of the Chair's text from the Intergovernmental Preparatory Meeting for CSD-13, as well as the Secretary General's reports and other relevant inputs.

Organization of Work

Discussions at CSD-12 highlighted that, whilst global efforts were essential, it is critical to consider the importance of regionally or nationally specific conditions when designing policies or programmes to overcome constraints and obstacles.

The CSD-13 **Intergovernmental Preparatory Meeting** (IPM) was mandated to consider policy options and possible actions to expedite implementation. A wide range of options and actions were discussed and considered. The Chair's text adopted at the conclusion of the IPM aims to capture these options and actions so as to best inform the subsequent discussions at CSD-13 (11 April – 22 April). Individual countries will of course determine which of the identified options and actions are likely to be most relevant to their own domestic or regional circumstances.

The organization of work for **CSD-13** can be divided into four parts:

• Part 1 (11April): Includes the **opening session** and a session on **regional perspectives** which should provide a clear picture of the practical measures that are most likely to expedite implementation of those policy options considered most relevant to a particular region.

Some practical measures will be achievable without additional regional or global effort.

- These practical measures will be included as an output of the meeting in the form of a summary as described in the Chair's introductory note.
- Voluntary commitments to mobilize further action by any implementation actor at this time will be noted as an output of the CSD-13 and will be included on the CSD website as a living document.
- Part 2 (12 13 April): **Interactive discussions** provide an opportunity **to focus deliberations** on those practical measures that will only be possible with further concerted effort at the regional or global level in the three thematic areas.
 - The output of the interactive discussions will be the Chair's draft elements for policy decisions on practical measures and options to expedite implementation.

- Part 3 (15-19 April): **Negotiations on the Chair's draft elements for decision**, with the purpose of reaching agreement on policy decisions on practical measures and options to expedite implementation, as described in the Chair's introductory note. A panel of Finance and Development Cooperation Ministers and Experts will address the economic benefits of implementing sound policies related to water, sanitation and human settlements on the afternoon of 18 April.
- Part 4 (20-22 April): High Level Segment. Ministers will be invited to discuss the way forward in ensuring the agreed policy decisions are implemented, based on the theme: "Turning Political Commitments into Action", and to adopt the CSD-13 outputs. A number of invited speakers will lead-off these interactive discussions. There will be two panel sessions on specific subjects: one focusing on MDG targets for water, sanitation and human settlements and the other on the impact of natural disasters-prevention and response in relation to water, sanitation and human settlements.

Throughout CSD-13, including its High Level Segment, all implementation actors will be encouraged to announce any **voluntary commitments** or activities that will mobilize further action in implementation, whether at a national, regional or global level. These commitments and activities will be captured on the CSD website and serve as an on-going source of information on practical implementation efforts, as described in the Chair's introductory note. It is intended that this information represent a "living document" open to the listing of new commitments or activities into the future.

The official output of the Thirteenth Session of the CSD will include:

- Negotiated policy decisions on practical measures and options to expedite implementation;
- A summary of: the regional perspective sessions; policy options and practical measures; the Highlevel Segment; the Partnerships Fair; and the Learning Centre; and
- Voluntary commitments to mobilize further action by implementation actors to be posted on the CSD website.

Major Groups

During the course of CSD-13 the **Major Groups** will be invited to participate as follows:

- In the interactive discussions on 12-13 April.
- On the 21 April, where Major Groups will outline their own aspirations and priorities for action in the course of an interactive discussion with Ministers.
- On 22 April, where Major Groups will make closing remarks on how they will support the implementation of CSD-13 policy decisions.

Partnerships Fair

CSD-13's official programme includes a **Partnerships Fair.** In keeping with the CSD-13 policy year focus on "practical measures and options to expedite implementation of commitments", the Partnerships Fair will highlight the lessons learned from partnerships for sustainable development, especially those working on the thematic cluster of water, sanitation and human settlements. At present, over one third of all partnerships registered with the CSD are working in areas related to this thematic cluster.

The main components of the Partnerships Fair are:

• "Partnerships in Practice" Interactive Discussion Sessions: The interactive sessions will promote discussion on practical issues related to partnerships, based on the real experiences of CSD registered partnerships. Several sessions will focus on lessons learned from partnerships directly working in the thematic areas of water, sanitation and human settlements. In addition, there will be sessions which will

focus on practical issues common to all partnerships (communication and outreach, finding new partners, funding, etc).

• Partnerships Information Desks & Display: Partnerships representatives will have the opportunity to display and distribute information and directly interact with CSD participants. This is an opportunity for visibility, networking and information-dissemination.

Learning Centre

A Learning Centre is part of the official CSD-13 programme and will be scheduled from 12 to 20 April.

Side Events

Side events, sponsored by Major Groups, Governments, IGOs and UN agencies, funds and programmes, will be organized as a complementary part of the CSD-13 Policy Session to generate informal opportunities for exchange of information and experience.

High-Level Segment: 20-22 April 2005

Characteristics of the High-level segment:

- This is an opportunity for Ministers to listen, discuss, and react where appropriate, to their colleagues in an interactive dialogue
- The over-riding theme is "Turning political commitments into action" for all three thematic areas
- A number of invited speakers will provide introductory remarks to help liven and stimulate the discussions, including: Mr. Robert Orr, UN ASG; Minister Borge Brende, Norway (CSD-12 Chair); His Royal Highness, the Prince of Orange, Netherlands; Mr. Mikhail Gorbachev, Chairman, Green Cross International; Ms. Sunita Narain, 2005 Stockholm Water Prize winner.
- Two specific- topic interactive discussions: *Meeting the MDG targets related to water, sanitation and human settlements*; and the *Impact of natural disasters on water, sanitation and human settlements- prevention and response*; during these sessions, Ministers are expected to focus their comments on these particular aspects.

Note that the MDG-related discussion on 20 April has been changed slightly and will now be from 11:00am to 12:15 pm.

- In summary, the hope is that Ministers and heads of delegations will truly interact and that there will not be too many statements.


