

Organization of Work for CSD-14 (Updated 24 April)

Introductory Note from the Chairman

The fourteenth session of the United Nations Commission on Sustainable Development (CSD-14) is scheduled to take place from 1 to 12 May 2006 at the United Nations Headquarters in New York. As a review session, CSD-14 is tasked with identifying barriers and constraints, lessons learned and best practices in implementation in the thematic cluster of *energy for sustainable development, industrial development, air pollution/atmosphere and climate change*.

As Chairman of CSD-14, I will do my utmost to help ensure that the review session will result in an improved understanding of priority concerns and lay the groundwork for an effective policy year. It is also my firm belief that CSD-14 can and should catalyse concrete action at the national, regional and international level by all stakeholders.

The thematic issues before CSD-14 are closely linked in their economic, social and environmental dimensions. These issues should be dealt with in an integrated manner, as called for by CSD-11. Means of implementation and other cross-cutting issues should also be addressed. We should avoid compartmentalizing these issues and putting them in silos. By adopting an integrated approach and relying on its unique strengths, the Commission can identify win-win action that maximizes synergies in implementation.

As the high-level body on sustainable development within the United Nations system, the Commission is widely expected to play a lead role in galvanizing action in implementation. Governments, international organizations and Major Groups look to the Commission for action-oriented initiatives. To make this happen, I will work in close collaboration with my colleagues on the Bureau, with fellow Ministers and Government representatives, as well as with Major Groups.

I will carry on the spirit of reform launched at CSD-11 and continue to improve the methods of work of the Commission to further enhance its dynamics and interactivity. The review session will benefit from national reports/case studies, Secretary-General's reports, outcomes of regional implementation meetings, contributions from UN agencies and Major Groups, as well as results of inter-sessional events.

CSD-14 will continue to feature a rich variety of activities through an enhanced Partnerships Fair, Learning Centre and Side Events. Announcements on these activities will soon be posted on the CSD Secretariat's website.

As I emphasized to my Bureau colleagues, our work does not start with the opening of CSD-14 on 1 May 2006. Our work starts now. Let's join forces to make CSD-14 a success. Working in partnership, we can make a difference.

The information provided below describes the proposed daily organization of work for CSD-14. Its purpose is to assist Governments, United Nations organizations and other relevant international organizations, as well as Major Groups, with their preparations for CSD-14. It is my hope that the early dissemination of this information will contribute to a dynamic, efficient and productive preparatory process, leading to a successful CSD-14.

General Introduction

By the decision of CSD-11, subsequently approved by ECOSOC, the review session of CSD in the two-year implementation cycle will focus on identifying barriers and constraints in implementation, as well as lessons learned and best practices in relation to its thematic cluster. CSD-14's thematic issues are *energy for sustainable development, industrial development, air pollution/atmosphere and climate change*.

Organization of Work

The organization of work for **CSD-14** can be divided into four parts:

- Part 1 (1-3 May) includes the **Opening; General Statements** focused on overview of progress in the implementation of Agenda 21, the Programme for the Further Implementation of Agenda 21 and the Johannesburg Plan of Implementation; and the **Multi-stakeholder dialogue** session.
- Part 2 (1-9 May) includes **Thematic discussions** and **Regional discussions** that provide an opportunity to focus deliberations on identifying barriers and constraints, lessons learned and best practices in relation to the four issues in the thematic cluster. Discussions will take place in parallel in Room 4 and Room 2 and will have equal footing.
- Part 3 (8 May) is **SIDS day** on the review of implementation of the Mauritius Strategy focusing on the thematic cluster of CSD-14.
- Part 4 (10-12 May) is the **High-level Segment**, featuring: (i) Ministerial interactive discussions entitled *The Way Forward* to address barriers and constraints and to provide guidance on areas to be focused on during the policy year; and (ii) Ministerial dialogue sessions entitled *Making a Difference* that will include one dialogue session with Heads of UN agencies, funds and programmes, relevant international and regional organizations; one dialogue session with representatives of Major Groups; as well as panels of Ministers of Energy, Industry and Development Cooperation, as well as IFIs.

Major Groups

During the course of CSD-14 the **Major Groups** will be invited to participate as follows:

- A dedicated Major Groups' multi-stakeholder dialogue session;
- A Ministerial dialogue session with Major Groups;
- Participation in Thematic and Regional discussions, the SIDS day, the Partnerships Fair, and the Learning Centre;
- Closing remarks on how Major Groups will initiate action in implementation in relation to the thematic cluster of issues.

Partnerships Fair

CSD-14's official programme includes a **Partnerships Fair**. In keeping with the CSD-14's focus on identifying barriers and constraints, lessons learned and best practices, the Partnerships Fair will highlight the lessons learned from partnerships for sustainable development, especially those working on the CSD-14's thematic cluster of issues. At present, over 60 partnerships registered with the CSD Secretariat are working in areas related to this thematic cluster.

The main components of the Partnerships Fair are:

- **“Partnerships in Practice”** Interactive discussions: Sessions will be organized to generate dialogue on practical issues related to partnerships in the CSD 14’s thematic cluster and on issues common to all partnerships, such as challenges related to communication strategies and funding;
- **Partnerships Presentations**: Registered partnerships, as well as new partnerships initiatives, will have the opportunity to present information about their initiatives and engage in discussion and Q&A (40 -50 minute time slots)
- **Partnerships Information Desks**: Representatives from registered partnerships will be able to display and distribute information on their respective partnerships and directly interact with CSD-14 participants.

Learning Centre

A **Learning Centre** is an integral part of the official CSD-14’s programme and will be scheduled from 1 to 9 May 2006. Courses will be given by experts with hands-on experience.

Side Events

Side events, sponsored by Governments, UN organizations, IGOs and Major Groups, will be organized as a complementary part of CSD-14 to generate informal opportunities for exchange of experience and lessons learned.

The outputs of CSD-14

The outputs of CSD-14 will include:

- A Chairman’s summary comprised of: (i) the Opening and General Statements focused on overview of progress in the implementation of Agenda 21, the Programme for the Further Implementation of Agenda 21 and the Johannesburg Plan of Implementation, as well as the Mauritius Strategy; the Thematic and Regional discussions; the SIDS day; and (ii) the High-level Segment, which will address barriers and constraints and provide guidance on priority areas to be focused on during the Intergovernmental Preparatory Meeting (IPM) and the policy session;
- Record of the Partnerships Fair, the Learning Centre, and the Multi-stakeholder dialogue session.

Matrix

- A tool prepared by the Secretariat, based on case studies and lessons learned, to be posted on the CSD Secretariat’s website. The Matrix will be **a work in progress** and will be continuously refined and updated throughout the two-year cycle as information from national reports/case studies becomes available. During CSD-14’s discussions, the Matrix will be updated on the basis of interventions and panel discussions on barriers and constraints, practical measures and success stories. The Matrix will be prepared in the overall context of Agenda 21 and the Johannesburg Plan of Implementation

Introduction

It will be recalled that CSD-13 decided to devote one day of the review sessions of the Commission to review of implementation of the Programme of Action for the Sustainable Development of Small Island Developing States, focusing on the respective year's thematic cluster, as well as on any new developments regarding the sustainable development efforts of the SIDS.

The first such review session will be held on Monday, May 8, at the start of the second week of CSD-14. It is expected that the programme will proceed as far as possible in a manner consistent with the format established for the broad thematic discussions being pursued in the wider CSD session.

Structure of the SIDS Day

The meeting will begin with a brief opening ceremony, and then move quickly into review of SIDS progress within the context of the thematic clusters, each introduced by specially invited panellists. Emphasis will be on practical initiatives which may be considered or adopted to strengthen the implementation of Mauritius mandates related to the CSD-14 themes.

Panellists will therefore be invited to share very specific experiences and best practices in SIDS, with a view to encouraging their further development, their replication in other SIDS, and the support of the donor community and agencies of the UN system for financing, investment and capacity building in SIDS, within the thematic framework.

Each thematic presentation will be followed by an intergovernmental exchange moderated by the Chair of the Bureau, during which Member States will have the opportunity to share experiences, successes and lessons learned, and to identify constraints and continuing challenges. It is during the intergovernmental exchange that SIDS representatives could avail themselves of the opportunity to make brief interventions focusing on programme implementation in their respective countries or regions, including a discussion on the means of implementation.
