REEEP's vision is to make energy systems sustainable

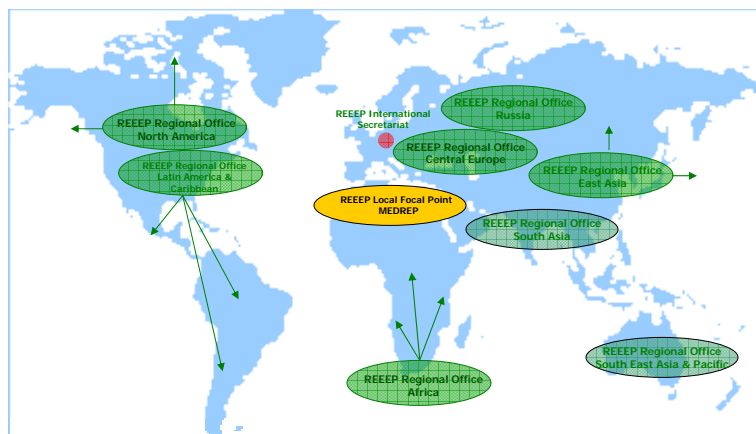
1. REEEP aims to reduce market barriers and financial obstacles for renewables and energy efficiency and so facilitate technology transfer

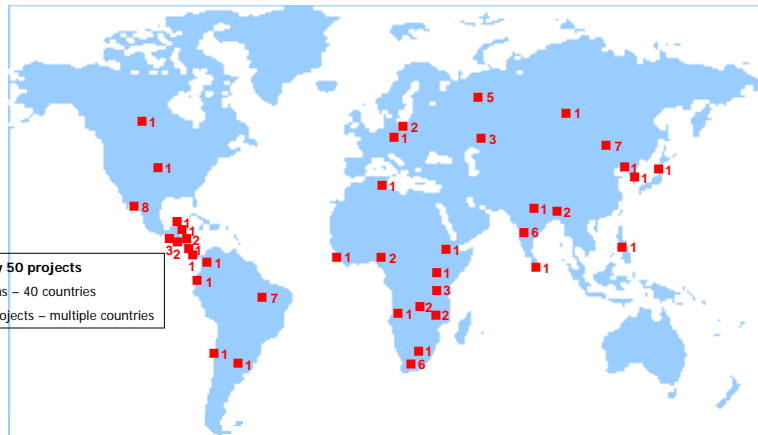
