Itaipu Hydroelectric Power Plant

- Joint Venture Brazil Paraguay on the basis of the Treaty signed on April 26, 1973
- Introduction of royalties to be paid by the binational entity as compensation to the two countries (US\$ 1.99/MWh, today's value)

Law 7990 (1989), Law 8001 (1990) and related legal rules

- Introduction of financial compensation (6% of the generation "tariff of reference") to be paid by generation companies (>10MW) to States and Municipalities affected by reservoirs (either local or upstream regularization reservoirs)
- Distribution of Proceeds <u>Applicable also to Itaipu's royalties:</u> 45% for States, 45% for Municipalities, 10% for the electricity regulatory agency*

*(40% for electricity services supervisory activities, 35% for water resources management and data gathering, and 25% for environmental protection)

Further changes in the use of proceeds have been brought by...

•Law 9433 (1997 - outlines the national water resources policies and guidelines, and introduces the concept of payment for water use)

And by ...

• Law 9984 (2000 – creates the national water regulatory agency and increases from 6% to 6.75% the amount to be paid by generation companies, the additional 0.75% being the payment for water use)

So that today's situation is...

- Generation companies pay 0.75% of R\$ 44.20
 per MWh for water use
 - use of the proceeds is responsibility of the national water regulatory agency
- Generation companies pay 6% of R\$ 44.20 per MWh (US\$ 0.93/MWh) and Itaipu pays US\$ 1.99/MWh as compensation for inundated areas
 - distribution of the proceeds is 45% for States, 45% for Municipalities, 10% for the Federal Government*

^{*(30%} for electricity services supervisory activities, 30% for national water resources secretary, and 40% for the national fund for Science and Technology)

The 2004 figures

 137 hydroelectric power plants with 145 reservoirs will pay over US\$ 400 million in financial compensation or royalties to 22 states and 593 municipalities:

Royalties (roy) and Financial Compensation (fc)

16 municipalities 325 municipalities 252 municipalities (roy only) (both roy and fc) (fc only)

Final Remarks on Itaipu

- Regional Development
 - Royalties paid to Brazil and Paraguay up to December, 2003: US\$ 4,582,000,000.00
 - Tourism: 12 million visitors since 1977,
 with recent average of 500,000 visitors/yr
 - Improvement in roads, bridges, avenues : over 240 km in the affected municipalities

Green boundaries

•110,000 ha with riverside forests, biological refuges and forest parks bordering 2,900 km of the 135,000 ha lake
