6. WSSD outcomes make specific reference to the roles scientific communities and educators could play in the next phase. What are your suggestions on possible ways the role of these major groups could be enhanced?
  
7. What other measures, mechanisms, or approaches would you recommend for further involving major groups in the work of the CSD?
