Report to the Senior Management Group

Inter-Departmental Group to Implement the Action Plan "An Era of Application of International Law"

I. <u>Introduction</u>

- 1. In 1999, a Sub-Committee of the Senior Management Group (SMG) established by the Deputy Secretary-General and chaired by the Legal Counsel prepared a report entitled "An Era of Application of International Law." Based on this report, the Sub-Committee developed an action plan, which was endorsed by the SMG and approved by the Secretary-General in June 2000 (the "Action Plan"). The Action Plan is available at http://untreaty.un.org/ola-internet/cover sheet.htm.
- 2. Item 1 of the Action Plan, encouraging participation in multilateral treaties, has been fully implemented by the Office of Legal Affairs (OLA). Item 2 of the Action Plan, assistance to states, has also been implemented to some extent in various ways. Item 2 seeks to facilitate assistance to states, which need such assistance on issues related to consolidating and advancing the international rule of law. Accordingly, the emphasis under this item now is on the domestic implementation of internationally incurred rights and obligations. This should be done in a well developed and coordinated manner with the aim of achieving the most focused and cost effective results given the limited resources available. To further this objective, OLA has established a web page on the International Law web site for providing information on available legal technical assistance to all who contact the United Nations seeking such assistance. II. Inter-Departmental Group

- 3. In order to implement the Action Plan, the Secretary-General, at a meeting of the SMG on 14 March 2002, authorized the Legal Counsel to establish an interdepartmental group with the following terms of reference:
 - "(1) Develop a system for central coordination among departments, offices, funds and programmes of the technical assistance that is, or should be, available, where there is demand and a mandate to provide such assistance.
 - (2) Develop a system for monitoring this coordination so as to avoid both lacunae and overlap, thus enhancing the effectiveness of the technical assistance in accordance with the Action Plan.

- (3) Develop a system, including through the use of the electronic medium, for informing Member States and the public of developments with regard to the Action Plan and opportunities for assistance under the plan.
- (4) Make recommendations regarding these matters to the SMG."
- 4. Accordingly, as authorized by the Secretary-General, an inter-departmental group (IDG) was established, consisting of 28 members (*see Annex I*) representing various United Nations units, departments, offices, agencies, funds and programmes. The Group met for the first time on 13 May 2002 and concluded its work on 17 September 2002.
- 5. The IDG is aware that the ECPS Task Force for Development of Comprehensive Rule of Law Strategies for Peace Operations, proposed by DPKO and comprised of representatives of 11 UN departments and agencies, recently examined possible coordination arrangements which might be established to assist DPKO's newly-approved Criminal Law and Judicial Advisory Unit (CLJAU). However, the mandate of this Task Force was limited to formulating options and recommendations for possible cooperative arrangements to be established between the CLJAU and UN system partners so that the necessary expert advice and resource support can be mobilized and provided to UN peace operations on rule of law issues. On the other hand, the IDG's scope of review was a more general one, focusing on given and potential mandates as reflected in its Terms of Reference.

III. System for central coordination among departments, offices, funds and programmes of the legal technical assistance

- 6. According to its terms of reference, the IDG was required to develop a system of effective coordination for the Secretariat units, departments, offices, agencies, funds and programmes, which provide legal technical assistance with a view to maximizing their effectiveness and avoiding duplication. In particular, if several agencies or organizations are providing legal technical assistance in respect of the same subject matter, they should endeavor to coordinate their programmes. Likewise, where legal technical assistance is needed but none is provided, attention should be drawn to such areas.
- 7. In order to achieve this objective, the IDG prepared a questionnaire to be able to determine the nature and scope of existing legal technical assistance programmes within the Organization. The questionnaire was circulated to all members of the IDG, and most of the responses were received in July 2002. These responses have been collated into a directory (*see* Annex II), which includes the following information: name of the entity, its primary clients, a summary of the legal technical assistance it provides and how it is implemented, the address of its web site if any, its legal technical assistance publications, the other means by which it disseminates this information and the nature of its collaboration with other offices.

8. Subject to the views of the SMG, it is proposed that this directory be made available on the Legal Technical Assistance web page on the International Law web site.

IV. Summary of Survey Results

9. The IDG also reviewed the results of the survey to assist in the processes of identifying any overlaps or gaps among the existing legal technical assistance programmes. Although the responses received do not, by themselves, immediately highlight areas of overlap or gaps, they clearly demonstrate the extent to which legal technical assistance is currently provided. An Index of Legal Technical Assistance Provided by United Nations Units, Departments, Offices, Agencies, Funds and Programmes was compiled (see Annex III). The index reflects an effort on the part of the IDG to identify the areas in which and the extent to which the relevant units, departments, offices, agencies, funds and programmes provide such legal technical assistance.

V. System for monitoring the coordination of technical assistance

- 10. In order to avoid both lacunae and overlap and subject to the views of the SMG, the IDG proposes the following for monitoring the coordination of technical legal assistance:
 - (a) Encourage and foster the creation of individual web sites on technical legal assistance within the Organization.
 - (b) Establish links among these web sites and the Technical Assistance web page on the International Law web site.
 - (c) Create an enhanced technical assistance web page, which will constitute a clearing house for information about technical assistance and through which the different units, departments, offices, agencies, funds and programmes will be able to share information in a simultaneous and proactive manner.

VI. System for informing Member States and the public of developments with regard to the Action Plan and opportunities for assistance under the plan

11. The IDG discussed various ways in which to disseminate the information collated to member States and the general public to keep them informed of opportunities for legal technical assistance. Subject to the views of the SMG, it is proposed that:

- (a) Member States be informed both in electronic format and in paper format about the findings of the IDG.
- (b) Specifically, members of the Third Committee and the Sixth Committee be informed about the findings of the IDG.

In addition:

- (c) The Legal Counsel will inform legal advisers to ministries of foreign affairs and legal advisers of the United Nations system of the findings of the IDG.
- (d) The Office of Legal Affairs will continue directing requests for legal technical assistance to appropriate units, departments, offices, agencies, funds and programmes.

VII. Recommendations

- 12. Based on the foregoing, the IDG recommends that the SMG endorse IDG's proposals in paras. 8, 10 and 11.
- 13. The IDG further recommends that the SMG should consider the task of the group completed with this report. However, the participants in the group should be encouraged to act as an informal network, while OLA should monitor the system by maintaining the Technical Assistance web page on the International Law web site.
