**Provisional Programme**

The preparatory meeting of experts in preparation for the high-level midterm review of the Istanbul Programme of Action will be convened from 28 to 31 March 2016 at the United Nations Headquarters in New York, pursuant to General Assembly resolution 69/231. The meeting will undertake substantive preparations for the midterm review, including a review of progress in the preparatory process for the midterm review, a comprehensive appraisal of the implementation of the Istanbul Programme of Action by the Least Developed Countries and their development partners. It will also identify effective international and domestic policies in the light of the outcome of the appraisal as well as new and emerging challenges and opportunities and the means to address them, reaffirm the global commitment to addressing the special needs of the Least Developed Countries and mobilize additional international support measures and action in favour of the Least Developed Countries.

In line with General Assembly resolution 70/216 the meeting will be chaired by the co-facilitators and will consider the draft outcome document of the midterm review. The meeting will be held in accordance with the attached programme, which will be updated as necessary during the week. In accordance with OP. 23 of General Assembly resolution 69/231, interpretation will be provided on an "as available" basis.
