# Rationale

The private sector has a role to play in the peace and security agenda of the United Nations. Yet many modalities for a more proactive role remain undefined both on the side of business and of the United Nations. The rationale for a proactive role for business seems clear: Rising geopolitical tensions and increasingly chronic instability in many established and emerging markets increase the stakes in the business community that the United Nations lives up to its purpose to maintain international peace and security. At the same time, there can be much potential to leverage the political power of business to diffuse tension and prevent conflict. While this rationale takes many diplomats and business people outside their comfort zone, rising conflict risk and challenged conflict resolutions and prevent conflict. Such partnership can build on two decades of collaboration on normative and funding issues and focuses on practical solutions to enhance peace and security in an era that desperately needs them.

# Background

This consultation is part of the preparatory process of a High-level Thematic Debate of the UN General Assembly focused on UN, Peace and Security that will take place in New York on 10-11 May 2016. The Debate will provide a platform to reflect on concrete ways to draw out synergies from the most recent UN peace and security reviews that have focused on peace operations, peacebuilding, and women, peace and security. The High-Level Debate is also an opportunity to guide the next Secretary-General in this and other equally vital tasks.
