







#### Regional Latin American Consultation: Insights for the High Level Thematic Debate on International Peace and Security

# Agenda

The Igarapé Institute, NUPI, Pandiá Calógeras Institute and IISS are co-hosting an informal consultation to provide inputs to the High Level Discussions of the UN General Assembly (UNGA) in May 2016. The primary goal is to help identify opportunities to promote an adequately resourced, relevant, coherent, efficient and effective UN architecture to promote international peace and security. The event, divided into four panels, will run from 10am to 4pm with light refreshments and a lunch provided by the organizers. Coffee/tea will be available throughout.

The introductory panel will set the stage for the consultation. The session will review the key reports associated with international peace and security, highlighting their implications for Latin America. A special message has been prepared by the President of the 70<sup>th</sup> UNGA. The following panels will address the key opportunities, synergies and main challenges for actually implementing each of the key UN agendas in the region. The goal is to have an open exchange of ideas with practical recommendations for the UNGA.

The agenda is designed to provide opportunities for substantive debate and informal interaction. The goal is not to repeat country views voiced in New York or the content of previous consultations on each of the individual reviews. Rather, the intention is to develop a better understanding of areas of consensus and divergence in Latin America and the Caribbean. Each panel will include up to 3 speakers (no more than 5 minutes each) who will trigger the debate and 1 individual to chair. Each panel will also be guided by a number of questions intended to structure the deliberations.

## 10.00-11.00 – Introductory panel

The opening panel will introduce the principle themes of the seminar and review the key objectives of the regional consultation. It will consider how Latin American countries are engaging with complex conflicts and asymmetric threats, addressing the causes of conflict, developing solutions for preventing conflict, and promoting gender mainstreaming in all its actions. The panel will also briefly touch on some of the challenges and opportunities for implementing the 2030 Agenda, from a Latin American perspective.

How to increase awareness on the critical importance of this agenda to achieve sustainable peace?
