As you are aware, we are currently leading the negotiations on the resolution determining the precise modalities for the intergovernmental conference on international migration, which will adopt the global compact in 2018, in our capacity as co-facilitators of the preparatory process for the global compact for safe, orderly and regular migration.

In resolution 71/280, Member States stipulated that the conference shall be held at United Nations Headquarters in New York, immediately prior to the opening of the general debate of the seventy-third session of the General Assembly, unless otherwise decided. The present modalities resolution should provide a final decision regarding the venue and exact date of the conference.

In this regard, we transmit to you a letter dated 9 October 2017 by the Government of Italy with an expression of interest to host the intergovernmental conference on international migration in 2018. We have further taken note of a letter dated 12 October 2017 by the Government of the Kingdom of Morocco addressed to your Excellency with a similar offer, also attached.

We are pleased to inform you that we have encouraged the delegations of Italy and Morocco to share their offers in greater detail on the occasion of the next informal consultation on the modalities resolution, to take place Wednesday, 18 October 2017 from 10:00 to 13:00 in the ECOSOC Council Chamber.

In order to ensure the open, transparent and inclusive nature of the negotiations, we kindly invite you to consider circulating the letters of both delegations to Member and Observer States.
