Development Goals, but as the United Nation and m member states look past 2015 and begin to develop a new set of sustainable development goals, *The Lancet* Commission on Investing in Health is calling on the international community to place the aim of achieving a "grand convergence" in global health at the forefront of the 2030 health agenda. The Commission's report—*Global Health 2035: A World Converging within a Generation*—published in *The Lancet* on December 3, 2013, unveiled a comprehensive investment framework to achieve convergence in key areas of global health, with clear guidelines for national governments and the international community. Commissioners on the panel will

highlight key findings and recommendations from the report to make the case for convergence to be endorsed as a bold new strategy to bring HIV/AIDS, TB and child deaths

down to universally low levels within a generation.
