## United Nations Convention on the Law of the Sea Montego Bay, 10 December 1982

Receipt of an amendment to the partial Submission made by the Republic of Fiji to the Commission on the Limits of the Continental Shelf in the Region of the Lau-Colville and Tonga-Kermadec Complex (South East Region)

The Secretary-General of the United Nations communicates the following:

On 20 April 2009, the Republic of Fiji submitted to the Commission on the Limits of the Continental Shelf, in accordance with article 76, paragraph 8, of the Convention, information on the limits of the continental shelf beyond 200 nautical miles from the baselines from which the breadth of the territorial sea is measured. According to Fiji, this was a partial submission.

On 30 April 2012, Fiji submitted an amended executive summary of the Submission.

On 8 July 2025, Fiji submitted an amendment to the Submission which, according to the coastal State, replaces in their entirety the Submission made on 20 April 2009 and the amended executive summary submitted on 30 April 2012.

According to Fiji, "[c]onsistent with the 2009 partial submission, and its 2012 amendment, this amended partial submission contains information on the delineation of the outer limits of the continental shelf of Fiji in the Region of the Lau-Colville and Tonga-Kermadec Complex ('South East Region') beyond 200 nautical miles from the baselines from which the breadth of the territorial sea of Fiji is measured".

In accordance with the rules of procedure of the Commission (CLCS/40/Rev.2), the present communication is being circulated to all Member States of the United Nations, as well as States Parties to the Convention, in order to make public the executive summary of the amendment to the Submission, including all illustrative maps and lists of geographical coordinates of points contained therein.
