Excellencies,

I wish to refer to my letters dated 27 and 30 October 2020, regarding the timetable and modalities for the consideration of the pending items on the agenda of the thirtieth Meeting of States Parties to the United Nations Convention on the Law of the Sea, as outlined in the annex to my letter dated 27 October 2020 (www.un.org/Depts/los/meeting_states_parties/documents/20201027vLetEF.pdf), which is also attached to this letter.

In accordance with the timetable and modalities in the annex, between 30 October and 11 November 2020, States Parties considered the following agenda items under "Cluster I" through an exchange of written statements: agenda item 10(c) (*Filling of a vacancy in the Commission*); agenda item 11(a) (*Report on budgetary matters for the financial periods 2017–2018 and 2019–2020*); agenda item 11(b) (*Appointment of Auditor for the financial years 2021–2024*); and agenda item 11(d) (*Amendments to the Financial Regulations of the International Tribunal for the Law of the Sea*).

Under agenda item 10(c), a statement was received from the Group of Eastern European States.

Under agenda items 11(a), (b) and (d), statements were received from the Registrar of the International Tribunal for the Law of the Sea and some delegations. An additional statement by the Registrar in response to delegations' statements was also received.

All statements were made available via a dedicated SharePoint site for the thirtieth Meeting of States Parties (access to which was provided to delegations, as well as on the website of the thirtieth Meeting of States Parties at <u>www.un.org/Depts/los/meeting_states_parties/thirtiethmeetingstatesparties.htm</u>).

I propose that the Meeting take note of the documents related to the above-mentioned agenda items and of the statements that were received.

In addition, I wish to propose the following actions and decisions based on the exchange of statements, for adoption at the in-person plenary meeting, which is tentatively scheduled for 9 December 2020:

- a) For agenda item 10(c): taking into account that the Group of Eastern European States has informed that no candidates have been identified to fill the remaining vacancy in the Commission allocated to that Group and that the Group remains seized on this issue and will continue its efforts to identify a candidate for the vacant seat in the Commission as early as possible, I propose that the thirtieth Meeting decide that the Secretary-General will circulate a call for nominations with a view to conducting a by-election for this vacant seat at the thirty-first Meeting of States Parties, provided that the President receives information from the Group of Eastern European States about potential candidates at least 14 weeks before the commencement of that Meeting and that, in the absence of such information, the Meeting would revert to the consideration of that matter under the agenda item "Commission on the Limits of the Continental Shelf".
- b) For agenda item 11(a): I propose that the Meeting take note with satisfaction of the report on budgetary matters for the financial periods 2017–2018 and 2019–2020 (<u>SPLOS/30/3</u>).
- c) For agenda item 11(b): taking into account (i) the quotations of five different audit firms relating to the appointment of an auditor for the financial years 2021–2024, provided by the Registrar of the Tribunal (<u>SPLOS/30/4</u>, para. 3); and (ii) the proposal that BDO be appointed as the auditor for the financial years 2021-2024, as it made the lowest of the five offers, I propose that the Meeting decide to appoint BDO as auditor for the financial years 2021-2024.
- d) For agenda item 11(d): taking into account the statements received on this sub-item, I propose that the Meeting approve the amendments to the Financial Regulations of the Tribunal, as set out in the annex to <u>SPLOS/30/6</u>, which would become effective on 1 January 2021 and apply to the financial period 2021 and subsequent financial periods, as per the proposed amendment to Regulation 14.1.

I would welcome your written comments, if any, on the proposed actions and decisions. Please convey your comments by 5 p.m. on Monday, 16 November 2020. Such comments should be sent by email to <u>doalos@un.org</u> (copying <u>santosuosso@un.org</u>). I propose to proceed, as outlined, on the understanding that the proposed actions and decisions would need to be formally adopted at the in-person plenary meeting in December. In accordance with the annex to my letter dated 27 October 2020, the consideration of the agenda items under "Cluster II" through an exchange of written statements will commence on 12 November 2020.

Within those time-periods:

1. Delegations are kindly requested to send their statements (in both PDF and Microsoft Word formats, whenever possible) to the Division for Ocean Affairs and the Law of the Sea (doalos@un.org).

2. DOALOS will post the statement(s) on the designated SharePoint website, in the folder(s) for the relevant agenda item(s): 30MSP - Statements

3. If an acknowledgment of receipt has not been received from the Division, the Delegation should presume that its statement was not received and should kindly resubmit the statement and enquire.

4. The following information should be included in both (i) the email subject line and (ii) the statement's header or title:

- name of the Meeting
- agenda item
- name of the Delegation

5. For ease of record-keeping, it is strongly recommended that Delegations submit separate statements for each agenda item under which they intervene.
