# **DESCRIPTION OF REQUIREMENTS**

L'Office des Nations Unies à Genève (ONUG) souhaite recevoir des expressions d'intérêt pour un appel d'offres qu'il a l'intention de lancer pour la fourniture de 32 barrières anti-intrusions modulables pour protéger les accès au Palais des Nations Genève, Suisse contre les véhicules bélier.

Le soumissionnaire doit être spécialisé dans la fourniture des barrières modulables. Sa structure, son organisation, ses moyens techniques doivent lui permettre d'assurer se type de prestations décrites.

-Les éléments doivent s'assembler rapidement et ne nécessiter aucun outil.

-La barrière doit s'adapter à toutes les surfaces et tous les terrains (y compris trottoirs et dénivelés).

-Le stockage doit demander un minimum de places.

-Le transport des éléments doit être facile.

-La longévité doit être optimale et l'entretien minimal.
