### DESCRIPTION OF REQUIREMENTS

1. The United Nations Peacekeeping Force in Cyprus (UNFICYP) intends to conduct a competitive solicitation exercise for the electrical rewiring of 11 accommodation buildings, tennis court and swimming pool area situated within Camp San Martin (CSM), Skouriotissa, Cyprus.
2. The requirement includes, but is not limited to the following:
  - electrical installation of surface mounted electrical wiring within all accommodation buildings including the provision of all necessary cable and equipment (distribution boards, switches, sockets, circuit breakers, trunking, light fittings ceiling fans and excavations).
  - electrical installation of all necessary cable, poles, lighting accessories and excavations for the tennis court and the swimming pool area.
3. The project also includes the removal of the existing cables and other materials (all cables and materials made redundant as a result of the installations shall remain the property of UNFICYP).
4. Interested vendors shall have the opportunity to attend the mandatory site visit as part of the solicitation exercise.
5. In this regard UNFICYP would like to identify vendors that would be interested to participate in the competitive solicitation exercises. Qualified vendors are requested to express their interest in the requirements by providing all relevant information including complete company details and experience profile using the attached Vendor Response Form, also available in our website [www.unficyp.org](http://www.unficyp.org).
