DESCRIPTION OF REQUIREMENTS

The United Nations Mission in Haiti, also known as Mission des Nations Unies pour la Justice en Haiti (MINUJUSTH), has a requirement for qualified service providers who have a proven track record in Providing Level 3 Hospital services, to support its operational requirements on “as and when required” basis.

1 Description of Service

1.2.1

The Level 3 hospital will comprise a general hospital facility that provides emergency medical services, outpatient specialist services, in-patient ward facility including intensive care unit, diagnostic and treatment facilities, as elaborated below to the United Nations Mission Staff.

1.2.2 The Services shall be provided to Military & Civilian Police (Uniformed Components) upon Referral Note issued by MINUJUSTH Chief Medical Officer (CMO) and for such service, the Hospital shall invoice to and paid by MINUJUSTH.

1.2.3 The Hospital shall be required to provide services to individual MINUJUSTH Civilian Staff and payment for services shall be made either directly from the Civilian Staff Member or through individual staff member’s medical insurance service provider such as Van Breda International or Cigna among others in accordance with the Hospital and the insurance company policy.

1.2.4 The Hospital shall be required to reserve sufficient beds/wards for MINUJUSTH -personnel at no additional cost guarantee availability of beds/wards at any given time.

1.2.5 The Hospital be close to Haiti, preferably located in a neighboring country within a 2-hour flight radius from Port -Au- Prince.

SPECIFIC REQUIREMENTS / INFORMATION (IF ANY)

1.3.1 The contract shall be awarded on an all-inclusive basis. The contractor shall be responsible for providing all the necessary personnel, supervision, and transport, any other equipment, material, consumables, supplies, and all necessary arrangements, to ensure the fulfilment of its obligations of the contract for its entire duration including any extension periods thereof.

1.3.2 The Contractor shall be fully responsible for the sustainment of all its personnel an ensuring that all the staff, equipment, material and supplies are in place by the date of the commencement of services agreed upon with MINUJUSTH.

1.3.3 The Contract is required on a non exclusive basis and for an initial period of one (1) year with an option to renew for one (1) additional one (1) year period (1+1 years) at the sole discretion of the UN subject to changes in operational requirements of MINUJUSTH, availability of funds, extension of MINUJUSTH mandate and satisfactory performance of the contractor.

1) Registering as a Vendor with the United Nations

Prerequisites for Eligibility

In order to be eligible for UN registration, you must declare that:

- A. Your company (as well as any parent, subsidiary or affiliate companies) is not listed in, or associated with a company or individual listed in:
 - I. the Compendium of United Nations Security Council Sanctions Lists (<https://www.un.org/sc/suborg/en/sanctions/un-sc-consolidated-list>), or
 - II. the IIC Oil for Food List website or, if listed on either, this has been disclosed to the United Nations Procurement Division in writing.
- B. Your company (as well as any parent, subsidiary or affiliate companies) is not currently removed or suspended by the United Nations or any other UN organisation (including the World Bank);
- C. Your company (as well as any parent, subsidiary or affiliate companies) is not under formal investigation, nor have been sanctioned within the preceding three (3) years, by any national authority of a United Nations Member State for engaging or having engaged in proscribed practices, including but not limited to: corruption, fraud, coercion, collusion, obstruction, or any other unethical practice;
- D. Your company has not declared bankruptcy, are not involved in bankruptcy or receivership proceedings, and there is no judgment or pending legal action against your company that could impair your company's operations in the foreseeable future;
- E. Your company does not employ, or anticipate employing, any person(s) who is, or has been a UN staff member within the last year, if said UN staff member has or had prior professional dealings with the Vendor in his/her capacity as UN staff member within the last three years of service with the UN (in accordance with UN post-employment restrictions published in ST/SGB/2006/15).
- F. Your company undertakes not to engage in proscribed practices (including but not limited to: corruption, fraud, coercion, collusion, obstruction, or any other unethical practice), with the UN or any other party, and to conduct business in a manner that averts any financial, operational, reputational or other undue risk to the UN.
