#### **DESCRIPTION OF REQUIREMENTS**

The United Nations Global Service Centre, Brindisi (UNGSC) seeks an appropriately qualified contractor for a turn-key project to prepare the executive design and carry out the electrical works for the connection of the Diesel Uninterrupted Power Supply System (DUPS) to the electrical network on the administrative side of the UNGSC compound. The aim of the project is to provide an electrical backup in case of power failure to all strategic UNGSC facilities.

The requirement includes the following:

- Civil works
- Contractor's safety plan (POS);
- b. Executive architectural and structural design;
- c. Site preparation and mobilization;
- d. Underground ducting;
- e. Construction of electrical substation in compliance with CEI 0-16;
- f. Disposal of all construction debris;
- g. Sites cleaning;
- h. Final structural test ("Collaudo statico").
- 2. Electrical works
- a. Contractor's safety plan (POS);
- b. Executive electrical design;
- c. All-inclusive maintenance plan in accordance with CEI 78-17;

- d. Provision, assembling and installation of medium tension electrical switchgear in compliance with CEI 0-16 (as per 'QMT 144' switchgear on the drawings);
- e. Provision and installation of a medium tension single conductor for the electrical connection of 1,2mw substation to the 144 substation;
- f. Provision and installation of pilot cable (cavo pilota);
- g. Provision, assembling and installation of medium tension electrical switchgear in compliance with CEI 0-16 (as per 'QMT 114b' switchgear on the drawings);
- h. Provision and installation of resin insulated transformer, rated power 800 kVA
- i. Provision and installation of main cabin switchboard (as per 'QBT 114b' switchgear on the drawings).
- j. Certificate of Conformity and Selectivity study, and eventual calibration of all substations & relevant equipment.

Splitting of award between Civil works and Electrical works shall be allowed.

The Project will consist of 3 phases:

- Phase One Study and Executive Design
- Phase Two Civil and Electrical works
- Phase Three –Testing

The Contractor shall provide all necessary material, tools, equipment, services, labor, and vehicles required for this project, and will be responsible for providing all that is necessary to fulfill its contractual obligations, including all submittals and certifications.

## Qualifications

Companies interested in participating to this bidding exercise shall be registered at the Chamber of Commerce business registry for at least the past three (3) years:

#### Civil Works

For civil engineering works such as underground ducting and construction of substations.

## 2. Electrical works

Under letter A of the Art. 1 of the Italian law No. 37, dated 22/01/2008 (starting from 01 January 2015): production, transformation, transportation, distribution, consumption of electricity, protection systems for atmospheric discharges and automation systems for doors, gates and barriers ("impianti di produzione, trasformazione, trasporto, distribuzione, utilizzazione dell' energia elettrica, impianti di protezione contro le scariche atmosferiche, nonché gli impianti per l' automazione di porte, cancelli, barriere").

The full technical requirements and details will be provided with a solicitation document to be issued at a later stage after the closing date for this EOI.
