# **DESCRIPTION OF REQUIREMENTS**

- 1.The African Union-United Nations Hybrid Operation in Darfur (UNAMID) is seeking an Expression of Interest (EOI) from fully qualified companies wishing to be considered for inclusion in a tender for the purchase, collection, removal and disposal of scrap from UNAMID areas of operation in accordance with international and/or local government on envirmental and safety measures.
- 2. The disposed scrap includes but is not limited to the mentioned UNSPSC items. These UNSPSC items are a representative example of similar items to be disposed of in the future.
- 3. Contractor service shall be on an as-and-when requested basis at the following locations: El Fasher, Nyala, Elgenina, Khartoum, Port Sudan, Zalengie, and Al-Dein and UNAMID team sites.
- 4. The contractor will be responsible for providing all necessary labour, vehicles, tools, heavyduty weigh scales, heavy duty forklifts/cranes, materials, replacement parts, transportation, permits and supervision of personnel in accordance with contractural commitments.
- 5 The contractor shall ensure that all its personnel, equipment, facilities, materials and supplies are fully mobilized by the mobilization date stipulated in the contract.
- 6. UNAMID is seeking to engage qualified, competent and licenced companies authorised by the Government of Sudan to perform these services. Your company must possess a Sudanese business license and be authorized by the Government of Sudan to operate in Sudan.
- 7. Companies intrested in providing the above services are invited to submit their expression of interest by e-mail or via hand delivery as indicated below along with required documents.
- 8. UNAMID intends to issue a solicitation to companies who are willing and able to execute these services.
- 9. The EOI does not consitute a solicitation, therefore submitting a reply to this EOI does automatically guarantee that your firm will be considered for receipt of the solicitation when issued.
