1. The Services includes but not limited to:

- Access Control/Searches: UNAMA access-controlled areas, pedestrians, vehicles, containers, cargo, luggage, personal carried items entering UN premises for explosive, open area, building and warehouse searches, VIP support at the direction of UN Integrated Security Guard Force security officers.
- Daily Patrols: In coordination with UN Integrated Security, EDD teams will conduct random daily patrols of UN compounds, for the purpose of providing a deterrent effect and conducting searches
- Exercise/Drills: Participate in the planning and execution of UN Compounds incident response exercises and drills.
- First Aid: The Bidder shall ensure that all personnel that will perform the tasks related to this contract are trained in first-aid including Cardiopulmonary Resuscitation (CPR).
- Equipment: The Bidder is to ensure that K9 handlers have all necessary appropriate and required equipment to perform the required services.

2. This notice is issued only to allow companies to express their interest; it does not constitute an invitation for submission of bid or proposals. Its purpose is to identify companies that would be interested and meets the EOI criteria in order to be invited to participate in the solicitation when issued. UNAMA reserves the right to change or cancel the requirement at any time during the EOI and/or solicitation
