DESCRIPTION OF REQUIREMENTS

L'Office des Nations Unies à Genève (ONUG) souhaite recevoir des expressions d'intérêt pour un appel d'offres qu'il a l'intention de lancer pour la maintenance de six groupes turbo-compresseurs de marque YORK au Palais des Nations à Genève.

L'ONUG est aujourd'hui équipé de six (6) groupes frigorifiques à compresseur centrifuge de marque YORK, tels que listés ci-dessous :

- a) Trois (3) de Type : YKGDH45CMES. Puissance : 2'000 KW. Année de construction : 2002. Fluide frigorigène : R134a
- b) Un (1) de Type : YKBABP25CGE (numéro 3). Puissance : 868 KW. Année de construction : 2002. Fluide frigorigène : R134a
- c) Deux (2) de Type : YKACAAP25CFF. Puissance : 860 KW. Année : 2004. Fluide frigorigène : R134a

Les prestations de maintenance comprennent essentiellement :

- a) Maintenance préventive forfaitaire annuelle : visite de contrôle et d'entretien préventif de chaque groupe.
- b) Maintenance curative hors forfait : intervention de dépannage au plus tard dans les huit (8) heures suivant l'appel de l'ONUG.
- c) Assistance technique téléphonique pendant les jours ouvrés.
- d) Mise à disposition de personnels qualifiés (technicien frigoriste) sur le site de l'ONUG en renfort des équipes en place pour des missions allant d'une semaine à plusieurs mois.

L'ensemble des travaux devra être réalisé suivant les normes et réglementations cantonales et fédérales du pays hôte en vigueur.

Le descriptif détaillé des prestations à fournir sera joint aux documents d'appel d'offres.

SPECIFIC REQUIREMENTS / INFORMATION (IF ANY)

L'adjudicataire du présent marché devra fournir les prestations demandées pour la durée d'un contrat de cinq (5) ans, précisément pour une période initiale de trois (3) ans avec la possibilité de deux périodes supplémentaires et consécutives d'une année chacune (3+1+1).

Les expressions d'intérêt doivent impérativement être reçues avant 18h, heure de Genève, le 07 mars 2019. Toutes les réponses seront traitées de manière strictement confidentielle.

Une visite obligatoire sera planifiée dans la procédure d'appel d'offres.

1) Registering as a Vendor with the United Nations

- B. Your company (as well as any parent, subsidiary or affiliate companies) is not currently removed or suspended by the United Nations or any other UN organisation (including the World Bank);
- C. Your company (as well as any parent, subsidiary or affiliate companies) is not under formal investigation, nor have been sanctioned within the preceding three (3) years, by any national authority of a United Nations Member State for engaging or having engaged in proscribed practices, including but not limited to: corruption, fraud, coercion, collusion, obstruction, or any other unethical practice;
