### **DESCRIPTION OF REQUIREMENTS**

TThe United Nations Interim Administration Mission in Kosovo (UNMIK) has a requirement for the Supply and Delivery of Transport Spare Parts (Tires and Batteries) to UNMIK MHQ, on an "as and when required basis".

UNMIK Transport Section needs to keep small quantities of tires and batteries materials in stock, therefore we need to establish the contract for the Supply and Delivery of Transport Spare Parts (Tires and Batteries) with a regional supplier, who can, at a short notice, deliver to UNMIK in accordance with its requirements.

These materials include, but not limited as per the attached Annex A.

The Contract will be for an initial period of one (1) year, with an option of extension for additional three (1+1+1) year periods. The Contractor shall be in possession of all relevant permits, amongst them but not limited to the "Business Registration Certificate and License" for such services in Kosovo.

The Contractor shall provide all required services, facilities and personnel, pursuant to the execution of the Contract. All costs incurred in connection to executing the Contract, shall solely be borne by the Contractor.
