DESCRIPTION OF REQUIREMENTS

REQUEST FOR EXPRESSION OF INTEREST

1. The United Nations Organization Stabilization Mission in the Democratic Republic of Congo (MONUSCO) intends to enter into a System Contract (i.e. long term agreement based on fixed prices and multiple deliveries on an "as and when required" basis) to establish a 2 years Contract and seeks Expression of Interest (EOI) from duly registered companies for the Provision of Construction Services for Transit Camp in Existing Binub Compund, Bujumbura

2. The purpose of this Expression of Interest (EOI) is to asses potential suppliers who can provide MONUSCO with the ability, skill and knowledge in respect to the provision of the Construction services for a transit camp in Binub Compund.

MONUSCO will undertake a competitive bidding exercise shortly and intends to issue a Request for Proposal (RFP) to those companies who would express their interest and to provide initial relevant information demonstrating their abilitity to fulfill MONUSCO requirements. In addition, the interested companies will be requested to complete UN Vendor registration for level 1 on the vendor database accessible on ungm.org (new vendor only). A detail Scope of Requirement (SOW) will be provided to companies short listed for receipt of the (RFP) documents.

3. The EOI should specify brief relevant information about the company including the company's profile, capacity/capability and experience.

Vendors will be shortlisted based on their ability to provide the relevant documents showing that they are authorized to undertake business in DRC. Interested vendors must also provide copy of the registration certeficate/license(s) of the company with their response.
