The United Nations Office at Nairobi (UNON) invites gualified interested firms to submit Expression of Interest (EOI) to participate in the upcoming tender exercise for supply and Installation of 20 KVA and 40 KVA UPS Units.

Background: UNON is mandated to provide reliable power to the various locations within the complex. The use of computers and the smooth running of ICTS services and security installations are crucial to the staff accomodated in the complex. These services are provided with UPS (Uninterruptible Power Supplies) for effective operation and avoidance of down time. To ensure business continuity and resilience, UNON intends to replace/upgrade the old UPS units with new ones incorporating newer technology and better reliability.
