REQUEST FOR EXPRESSION OF INTEREST

1. The United Nations Organization Stabilization Mission in the Democratic Republic of the Congo (MONUSCO) has a requirement to establish a contract for the provision of Hot Mix Asphalt and Bituminous Primer for executing various projects in Kinshasa, Democratic Republic of Congo.

MONUSCO will undertake a competitive bidding exercise shortly and accordingly intends to issue an Invitation to bid (ITB) to those companies who would express their interest and provide initial relevant information demonstrating their ability to fulfill MONUSCO requirements. In addition, the interested companies will be requested to complete UN Vendor registration preferably for level 1 on the vendor database accessible on ungm.org.
3. Please note that this request for EOI is not an invitation for submission of a proposal.

MONUSCO reserves the right in selecting the invitees for the competitive bidding based on substantial and proven records of performance in the subject field of activities and submission of an EOI would not automatically warrant receipt of the (RFP) documents. MONUSCO reserves the right to reject EOIs received after the deadline indicated below.

1) Registering as a Vendor with the United Nations
