DESCRIPTION OF REQUIREMENTS

The United Nations Office at Nairobi (UNON) on behalf of the United Nations Human Settlements Programme (UN-Habitat) hereby invites qualified companies to submit their Expression of Interest (EOI) to participate in the upcoming competitive bidding exercise for the provision of services for the elaboration of Munciple Urban Development Programs ans Partial Plans for Urban centers and the surroundings of Tren Maya stations in the southeast region of Mexico .

UNON invites companies to express their interest by filling out the vendor response form and sending it either electronically or via email.

The United Nations Human Settlements Programme (UN-Habitat) is seeking expressions of interest from companies interested in participating in a solicitation process to identify a suitable vendor to generate the territorial and urban planning programs at municipal scale, the partial plans, normative instruments and/or urban guidelines necessary to guide the physical growth and the integrated development of urban settlements in the surroundings of the Tren Maya stations in accordance with the regulations of each state and the federal guidelines on the matter. The successful bidder will be required to propose the legal, administrative, participatory instruments necessary for the proper execution of plans or programs and the necessary mechanisms to operationalize the execution of Integrated Urban Operations (OUI), including public order agreements -state or municipal- that should be made

The vendor should provide the following services:

1 Collect and systematize the required urban, social, economic and environmental and normative

information

2 Collect and systematize the required cartographic information

3 Analyze and systematize the existing diagnoses, as well as elaborate the necessary ones.

4 Elaborate 4 Municipal Urban Development Programs and 2 Partial Plans

5 Validate results

6 General technical support on the services previously described.

1. Elaboration of 4 Municipal Urban Development Programs (PMDU) in the south east of México

2. Elaboration of 2 Partial plans (PP) for the polygons to intervene, bordering "Tren Maya" stations.

1) Registering as a Vendor with the United Nations

Prerequisites for Eligibility

In order to be eligible for UN registration, you must declare that:
