DESCRIPTION OF REQUIREMENTS

DESCRIPTION OF REQUIREMENTS

The United Nations Office at Nairobi (UNON) is seeking Expressions of Interest (EOI) from competent and qualified companies for the rehabilitation of a 3.2 km long gravel road that connects Midnimo Village to Kismayo town. The works are carried out under UN-Habitat's the Midnimo (Unity) Project - Support for the Attainment of Durable Solutions in Areas Impacted by Displacement and Returns in Jubaland and South West States.

The work will take place in Kismayo, Lower Juba region, Jubaland. The scope of works consists of rehabilitation works for a 3,246 meter long and 7 meter wide gravel road with 0.3 meter of well-compacted hardcore gravel to produce a smooth surface with gradients corresponding to the technical specifications. A 1 meter wide drainage and 1.4 meter wide foot-path are included along both sides of the 7 meter wide carriage way.

The scope of works includes, but is not limited to the following components:

- Site clearance and preparation works
- Hardcore layer works: hardcore gravel
- Heavy machine works: leveling and compaction
- Drainage works: excavation and wall construction

For the implementation of the works, all materials and equipment are to be procured or produced by the Contractor. Additional details, specifications and terms of reference shall be provided in the tender document to be issued subsequent to this EOI.

UNON invites companies to express their interest by filling out the vendor response form and sending it either electronically or via email.
