REQUEST FOR EXPRESSION OF INTEREST

The United Nations Organization Stabilization Mission in the Democratic Republic of the Congo ("MONUSCO"), seeks Expressions of Interest (EOI) from duly registered and licensed companies for the Maintenance and Operations of Electrical network, Heating, Ventilation and Cooling (HVAC) Services in its premises found in the following locations:

- Kinshasa, Goma, Kalemie, Manono, Beni, Butembo, Lubero, Bunia, Bukavu, Uvira, Kananga, Tshikapa, Kindu and in any other location where MONUSCO camp will be established in DR Congo and
- MONUSCO Logistic Base in Entebbe including all communication repeater sites in Kololo, Dundo, Katabi and any other sites which may be required the services in vicinity of Entebbe, Uganda
- MONUSCO Transit Camp in Bujumbura, Burundi .

2. MONUSCO will undertake a competitive bidding exercise shortly and accordingly intends to issue a Request of proposal (RFP) to those companies who would express their interest and provide initial relevant information demonstrating their ability to fulfill MONUSCO requirements. In addition, the interested companies will be requested to complete UN Vendor registration preferably for level 1 on the vendor database accessible on ungm.org.

3. The EOI should specify brief relevant information about the company including the company's profile, capacity/capability and experience. Vendors will be shortlisted based on their ability to provide the relevant documents showing that they are authorized to undertake business . Interested vendors must provide the following documents with their response:
