## **DESCRIPTION OF REQUIREMENTS**

## INTRODUCTION:

The United Nations Office at Nairobi (UNON) on behalf of UN Environment invites qualified firms to participate in a pre-qualification process for the upcoming competitive tender process for Safeguarding, transport and disposal of PCB contaminated oils and equipment containing PCB in Cameroon. This shall result into a Contract for a period of 2 years.

## 1. BACKGROUND

With the objective of assisting Cameroon to satisfy its obligations set out under the Stockholm Convention, a project is being implemented in Cameroon entailing the safeguarding and disposal of PCB contaminated oil and equipment. Under this part of the project it is intended that electrical equipment items and oils with a concentration of PCB of more than 2000ppm will be exported for disposal. Where equipment items have demonstrated to show PCB content of equal to or more than 50ppm and less than 2000ppm, only the oil will be safeguarded and disposed of.

As part of safeguarding and disposal activities, the eventual Contractor will visit each site where the equipment is stored and conduct safeguarding of PCB contaminated oil and equipment. Following safeguarding the eventual Contractor will then transport the equipment to the Fako Temporary Facility (TSF) close to Douala. Once centralised, the contaminated equipment and oil will be loaded onto shipping containers following which the eventual Contractor will then arrange safe transport and disposal according to the Basel and Stockholm Conventions and other relevant national and international law.

## 2. ASSIGNMENT OBJECTIVE

The primary objective of this tender is the safeguarding and centralization, loading and transport and international disposal in an environmentally sound method of an approximate total of 573 metric tonnes of PCB contaminated oils and equipment.

## 3. SERVICES TO BE PROVIDED

The following services are to be provided:

- Provision of personnel with requisite experience in safeguarding, loading, stowage and transport of hazardous wastes, including PCB contaminated oil and equipment
- Procurement and provision of necessary materials and equipment
- Health, Safety and Environmental planning and execution
- Inventory validation and update
- Provision of ISO shipping containers
- Repackaging and labelling of wastes according to IMDG using UN specified containers
- Centralization of PCB contaminated materials to the Fako TSF Douala
- Supervision of loading and stowage of repacked wastes according to IMDG /ADR using necessary spillage containment
- Transport of shipping containers to disposal facility
- Disposal of wastes using an environmentally sound method at a registered facility overseas

## SPECIFIC REQUIREMENTS / INFORMATION (IF ANY)

The purpose of this EOI is to pre-qualify potential vendors who will be invited to participate in the upcoming tender exercise. Below are the criteria that will be used to pre-qualify the Vendors:

- i. Experience in hazardous waste disposal services of more than 1000 Metric Tonnes of waste per year
- ii. Experience of POPs waste destruction of more than 750 Metric Tonnes per year
- iii. Experience of on-site operations in the last 5 years (for an international organisation) of more than 750 Metric Tonnes of hazardous waste per year
- iv. Vendors to provide a minimum of 3 contract details of previous works in a developing or country with an economy in transition in the last 5 years.

Pre-qualification documents should be submitted to the following email address:margaret.muchuku@un.org, with a copy to unon-procurement-rfx@un.org. Only those vendors who meet the above criteria will be pre-qualified and invited to participate in the tender exercise.

Vendors must be registered and accepted at Level 2 under the United Nations Secretariat in United Nations Global Marketplace (www.ungm.org). See the Vendor Response Form of this EOI for additional instructions.

UNON reserves the right to change or cancel the requirement of this EOI at any time during the EOI and/or solicitation process.
