DESCRIPTION OF REQUIREMENTS

The United Nations has a requirement to implement the capacity to transmit video and imagery from sensors deployed in the deep field in the UNs Peace Operations. These sensors include the fleet of Micro and Mini UAS (The UAS fleet is composed of Micro UAS such as the DJI Mavic 2 Enterprise, Mavic 2 Pro, Parrot Anafi and Phantom 4 Pro but is regularly updated with the latest technologies.), vehicle-dash cameras and Go Pro cameras. This video and imagery will be transmitted utilizing the satellite communications available in the field. UN Missions are equipped with a range of different commercial satellite communication systems such as Thuraya, Inmarsat (BGAN) and Iridium. In addition, there also exists proprietary satellite communications and commercial internet capacity in some remote regions.

The requirement is for an off the shelf product suite (e.g. hardware, software, licenses, etc.) to enable the transmission of data (images and video) from sensors such as Micro and Mini UAS during flight or immediately on landing, that are operating in remote areas without any LTE or Wi-Fi networks, via satellite phones, to the Sector, Force and Mission HQ as well as to other parts of the UN.

The detailed technical requirements shall be provided in solicitation documents to short listed companies/vendors. Those interested in this published EOI must submit the following documentation;
1. Vendor Response Form – complete the blank form as provided on page 4 of this document.
2. The Company should be registered in UNGM and provide UNGM number or UMOJA number if possible.
3. Company profile with Documentation to prove the company has licenses and experience in providing such technology.

This EOI does not constitute a solicitation. UN reserves the right to change or cancel the requirements at any time during the EOI and/or solicitation process. Thus, submitting a reply to this EOI does not automatically guarantee that your firm will be considered for receipt of the solicitation when issued.

1) <u>Registering as a Vendor with the United Nations</u>
