REQUEST FOR EXPRESSION OF INTEREST

The United Nations Organization Stabilization Mission in the Democratic Republic of Congo (MONUSCO) iseeks Expression of Interest (EOI) from duly registered companies for the provision of Freight forwarding service for Membrane Covered Framed Structures from FCA Quingdao Port, China to Door Entebbe MONUSCO Regional Office, Uganda

2. The purpose of this Expression of Interest (EOI) is to asses potential suppliers who can provide MONUSCO with the ability, skill and knowledge in respect to the provision of freight service as specfied above.

MONUSCO will undertake a competitive bidding exercise shortly and intends to issue an Invitation to Bid (ITB) to those companies who would express their interest and to provide initial relevant information demonstrating their abilitity to fulfill MONUSCO requirements. In addition, the interested companies will be requested to complete UN Vendor registration for level 1 on the vendor database accessible on ungm.org (new vendor only). A detail Scope of Work (SOW) will be provided to companies short listed for receipt of the (ITB) documents.

3. The EOI should specify brief relevant information about the company including the company's profile, capacity/capability and experience.

- provide us with a list of similar projects or orders already completed

Vendors will be shortlisted based on their ability to provide the relevant documents showing that they are authorized to undertake business in DR Congo and Uganda. Interested vendors must also provide copy of the registration certeficate/license(s) of the company with their response.

4. The requested information will only be used by MONUSCO for internal planning purposes, be kept strictly confidential and only authorized personnel will have access to it.
