United Nations Office at Nairobi (hereinafter referred to as UNON) on behalf of the United Nations Human Settlements Programme (UN-HABITAT) Iraq Programme is seeking to establish Contract with a qualified contractor(s) towards the Construction of low-cost housing units in Dkory, Sinjar, Ninewa Governorate, Iraq.

The scope of work consists of civil, sanitary and electrical works;

- Civil Works: include site preparation, concrete structural works for a one floor building; from foundation to roof, including concrete-block walls and partitions. Cement and gypsum plastering, installation of doors and windows, painting (emulsion and oil-based), roof waterproofing.
- Sanitary/Plumbing Works: water and drainage systems with water tanks, kitchen and bathroom facilities, septic tanks, etc. including connection to the public facilities.
- Electrical Works: complete electrical system power and lighting, inclusive of connection to the power grid.
- Labour: To support local livelihoods in the project area, the contractor is encouraged to recruit local unskilled labourers among unemployed residents from the targeted neighbourhoods. Skilled labour and key technical staff are excluded from this requirement.

Additional details, specifications, and terms of reference shall be provided in the tender document to be issued subsequent to this EOI. UNON invites companies to express their interest by filling out the vendor response form and sending it either electronically or via email

Interested vendors may forward their Expressions of Interest (EOI) along with the signed vendor forms. All EOI submissions should be sent via email, citing the EOI reference number and title in the subject line.
