**DESCRIPTION OF REQUIREMENTS**

The United Nations Office at Nairobi (UNON) invites suitably qualified civil engineering construction firm/s to submit their Expression of Interest (EOI) to participate in the upcoming competitive bidding exercise for Phase 3 design and construction services to renovate internal roads and associated car parking lots together with footpaths, bikeways and street lighting at the UNON Complex, Gigiri.

The firm is required to have experience in construction within the following discipline; civil engineering road construction and renovation.

Subsequent to the closing date of this EOI, UNON intends to issue a formal solicitation document to potential companies who have expressed interest to provide the services in accordance with the requirements that will be fully specified in the solicitation document.

The complete details of qualification requirements will be provided in the solicitation document.



Given the nature of the works, it is expected that the construction firm should be well equipped to carry out construction activities in the civil engineering discipline. The lead company/firm shall comply with all requirements related to the construction industry as stipulated by the Government of Kenya, i.e. amongst others, registration with Kenya's National Construction Authority (NCA) under road works category.

UNON reserves the right to change or cancel the requirement of this EOI at any time during the EOI and/or solicitation process. Thus, submitting a reply to this REOI does not automatically guarantee your company will be considered for receipt of the solicitation when issued. Only Vendors which in UN's sole discretion are deemed eligible and qualified upon completion of an objective evaluation of their EOI submissions may receive the final tender solicitation documents.

### **SPECIFIC REQUIREMENTS / INFORMATION (IF ANY)**

Interested firms responding to this EOI must meet the following pre-qualification criteria:

1) Valid Company Documents for the Prime Contractor:

Vendor shall provide Certificate of Incorporation (or equivalent Certificate) showing proof of ten (10) years of construction experience as an established Main (Primary) General Civil Contractor.

Documents required: Copies of Certificates (in English or translated into English).

2) Vendor shall provide at a minimum a NCA-3 registration certificate for Road Works and Electrical Works (<https://www.nca.go.ke/>) (or equivalent registration for international bidders).

Documents required: Copies of certificates (in English or translated into English).

3) In case of sub-contracting, the vendor shall submit a written statement confirming that:

3.1 Signed agreements from the domestic sub-contractors will be provided during the solicitation process in the following category:

- Electrical installation works;
- Civil Engineering design consultant;

3.2 The Certificate of Incorporation (or equivalent Certificate) for each proposed sub-contractor will be provided during the solicitation process showing proof of minimum 5 (five) years of experience as an established specialist in their relevant field expertise.

Documents required: Written statement from the main contractor on 3.1 and 3.2

Please note that this REOI is not an invitation for submission of tenders. Its purpose is to identify companies that would be interested and eligible to participate in the solicitation when issued. Companies interested in providing the above services should submit a completed Vendor Response Form. UNON will examine the outcome of this request for EOI and will consider those companies that have expressed their interest providing the required information as to their ability to fulfill the requirement. UNON reserves the right to change or cancel the requirement at any time during the EOI and/or solicitation process. Thus, submitting a reply to this Request for EOI does not automatically guarantee your company will be considered for receipt of the solicitation when issued. Vendors that are deemed qualified upon completion of an objective evaluation of their EOI submission will receive the final tender solicitation documents.

## EOI INSTRUCTIONS

### 1) Registering as a Vendor with the United Nations

Vendors interested in fulfilling the requirement described above must be registered at the UN Global Marketplace ([www.ungm.org](http://www.ungm.org)) with the UN Secretariat in order to be eligible to participate in any solicitation. Information on the registration process can be found at <https://www.un.org/Depts/ptd/vendors>.

#### **Prerequisites for Eligibility**

In order to be eligible for UN registration, you must declare that:

- A. Your company (as well as any parent, subsidiary or affiliate companies) is not listed in, or associated with a company or individual listed in:
  - I. the Compendium of United Nations Security Council Sanctions Lists (<https://www.un.org/sc/suborg/en/sanctions/un-sc-consolidated-list>), or
  - II. the IIC Oil for Food List website or, if listed on either, this has been disclosed to the United Nations Procurement Division in writing.
- B. Your company (as well as any parent, subsidiary or affiliate companies) is not currently removed or suspended by the United Nations or any other UN organisation (including the World Bank);
- C. Your company (as well as any parent, subsidiary or affiliate companies) is not under formal investigation, nor have been sanctioned within the preceding three (3) years, by any national authority of a United Nations Member State for engaging or having engaged in proscribed practices, including but not limited to: corruption, fraud, coercion, collusion, obstruction, or any other unethical practice;
- D. Your company has not declared bankruptcy, are not involved in bankruptcy or receivership proceedings, and there is no judgment or pending legal action against your company that could impair your company's operations in the foreseeable future;
- E. Your company does not employ, or anticipate employing, any person(s) who is, or has been a UN staff member within the last year, if said UN staff member has or had prior professional dealings with the Vendor in his/her capacity as UN staff member within the last three years of service with the UN (in accordance with UN post-employment restrictions published in ST/SGB/2006/15).
- F. Your company undertakes not to engage in proscribed practices (including but not limited to: corruption, fraud, coercion, collusion, obstruction, or any other unethical practice), with the UN or any other party, and to conduct business in a manner that averts any financial, operational, reputational or other undue risk to the UN.

**For Registered Vendors:** Vendors already registered at the UN Global Marketplace with the UN Secretariat must ensure that the information and documentation (e.g. financial statements, address, contact name, etc.) provided in connection with their registration are up to date in UNGM. Please verify and ensure that your company is registered under its full legal name.
