DESCRIPTION OF REQUIREMENTS

The United Nations Office at Nairobi (UNON), on behalf of Climate Technology Centre and Network (CTCN), United Nations Environment Programme (UNEP) invites qualified interested firms to submit Expression of Interest (EOI) to participate in the upcoming solicitation for provision of technical assistance implementation of the Technical Assistance on "Developing a national framework for the standardization of stalls and procedures for a climate smart street side vendor throughout The Bahamas."

United Nations Environment Programme (UNEP) on behalf of the Climate Technology Centre and Network (CTCN) requires the services of an institution to deliver the technical assistance as approved by National Designated Entity from The Bahamas. The overall objective of the Technical Assistance is to develop a framework and feasibility study to implement standardization of stalls and a sustainable program for the establishment of open green spaces for Street Side Vendors.

Currently at The Bahamas, 90% of the food is imported, and there are many street side vendors, who are operating out of the normal and unrecorded. The goal is to organize them more into the formal economy. As stated by The Most Honorable Prime Minister of The Bahamas: "Over the years there has been a proliferation of Street-side vendors. This phenomenon has resulted in several unfortunate developments



including but not limited to:

- unsightly makeshift facilities,
- unsafe placement of vendor carts or booths,
- illegal placement of vendor carts or booths,
- unsanitary vendor operations, and
- evasion of proper government business and regulatory protocols.

In The Bahamas there is a need for a greater commitment to strengthen strategic planning mechanisms for the empowerment of Bahamians. In recent years economic hardship and a lack of regulatory enforcement has led to a greater manifestation of the parallel economy, including street vendors selling food from vehicle trunks on roadsides and on construction sites, peanut vendors, fish vendors, and makeshift roadside stalls. The ultimate goal is to remove all roadside vendors, into zones. Starting first with New Providence, the largest island, establish 5 zones and then each zone will have 2 open marketplaces, where the vendors will be organized. It is the Government's intention to regulate roadside vendors to ensure that the activity of supplying goods and services are organized in safe green spaces for buyers and sellers. This is particularly important as the country adjust to changes in a post Covid-19 economy

This technical assistance seeks solutions for hazard risks to the island of New Providence from climate change events, advocates for the introduction of green spaces to increase liveability and proposes innovative mechanisms for storage of produce and goods. This innovative new concept will be accompanied by a policy that will lead the vendors towards these open green spaces, so they will no longer be on the streets. Resilience will increase as a result, having a great impact on the livelihood of the people in The Bahamas, namely on the island of New Providence.

Some of the expected outputs are:

- i. Development of implementation planning and communication documents;
- ii. Analysis of key stakeholders and consultations;
- iii. Market assessment for open green market spaces;
- iv. Establishing baseline/site selection for two open green market spaces;
- v. Establish a framework of requirements, capacity and loads of renewable energy systems, organic waste produce and water management;
- vi. Feasibility assessment of applicable climate technologies on open green market spaces and their sustainability;
- vii. Business model for open green spaces/markets to function effectively and governance

The complete details of the requirement will be provided in the tender documents that will be issued to bidders after this request for EOI is closed.



SPECIFIC REQUIREMENTS / INFORMATION (IF ANY)

The Climate Technology Centre and Network (CTCN) is the operational arm of the United Nations Framework Convention on Climate Change (UNFCCC) Technology Mechanism and co-hosted by the United Nations Environment (UN Environment) in collaboration with the United Nations Industrial Development Organization (UNIDO) and supported by 11 partner institutions with expertise in climate technologies. The mission of the CTCN is to promote accelerated development and transfer of climate technologies at the request of developing countries for energy-efficient, low-carbon and climate-resilient development.

CTCN provides technical assistance to the countries using its own funds (which it receives through voluntary contributions of donor). The requests for Technical Assistance (TA) are submitted to the CTCN by the National Designated Entity (NDE) of the respective country. In this present case the CTCN has developed a response plan and proposal which was submitted to The Bahamas for approval. The scope of services under these Terms of Reference shall be executed based on a restricted solicitation process where only accepted Members of the CTCN Network, are eligible to submit proposals.

In case you are not a CTCN network member yet, you may apply for this REOI and subsequent solicitation (Request for Proposal), subject to the condition that you submit your completed application for CTCN membership before the proposal submission closing date, which will be communicated in the subsequent Request for Proposal in due course of time. Furthermore, the contract award – should your proposal be selected – is conditional to your application for CTCN network membership being approved by CTCN management. The requirement to join the CTCN network is only relevant to the main bidder and no subcontractors. Please find more information to join CTCN Network at- <https://www.ctc-n.org/network>

The purpose of this REOI is to identify suitable firms who may be invited for the Request for Proposal after the REOI is closed. In addition to CTCN registration, all applicants should also be registered (free of charge) at United Nations Global Marketplace (www.ungm.org).

Please note that this REOI is not an invitation for submission of tenders. Its purpose is to identify companies that would be interested and eligible to participate in the solicitation when issued. Companies interested in providing the above services should submit a completed Vendor Response Form. UNON will examine the outcome of this request for EOI and will consider those companies that have expressed their interest providing the required information as to their ability to fulfill the requirement. UNON reserves the right to change or cancel the requirement at any time during the EOI and/or solicitation process. Thus, submitting a reply to this Request for EOI does not automatically guarantee your company will be considered for receipt of the solicitation when issued. Vendors that are deemed qualified upon completion of an objective evaluation of their EOI submission will receive the final tender solicitation documents. EOI INSTRUCTIONS

1) Registering as a Vendor with the United Nations

Vendors interested in fulfilling the requirement described above must be registered at the UN Global Marketplace (www.ungm.org) with the UN Secretariat in order to be eligible to participate in any solicitation. Information on the registration process can be found at <https://www.un.org/Depts/ptd/vendors>.

Prerequisites for Eligibility

In order to be eligible for UN registration, you must declare that:

- A. Your company (as well as any parent, subsidiary or affiliate companies) is not listed in, or associated with a company or individual listed in:
 - I. the Compendium of United Nations Security Council Sanctions Lists (<https://www.un.org/sc/suborg/en/sanctions/un-sc-consolidated-list>), or
 - II. the IIC Oil for Food List website or, if listed on either, this has been disclosed to the United Nations Procurement Division in writing.
- B. Your company (as well as any parent, subsidiary or affiliate companies) is not currently removed or suspended by the United Nations or any other UN organisation (including the World Bank);
- C. Your company (as well as any parent, subsidiary or affiliate companies) is not under formal investigation, nor have been sanctioned within the preceding three (3) years, by any national authority of a United Nations Member State for engaging or having engaged in proscribed practices, including but not limited to: corruption, fraud, coercion, collusion, obstruction, or any other unethical practice;
- D. Your company has not declared bankruptcy, are not involved in bankruptcy or receivership proceedings, and there is no judgment or pending legal action against your company that could impair your company's operations in the foreseeable future;
- E. Your company does not employ, or anticipate employing, any person(s) who is, or has been a UN staff member within the last year, if said UN staff member has or had prior professional dealings with the Vendor in his/her capacity as UN staff member within the last three years of service with the UN (in accordance with UN post-employment restrictions published in ST/SGB/2006/15).
- F. Your company undertakes not to engage in proscribed practices (including but not limited to: corruption, fraud, coercion, collusion, obstruction, or any other unethical practice), with the UN or any other party, and to conduct business in a manner that averts any financial, operational, reputational or other undue risk to the UN.

For Registered Vendors: Vendors already registered at the UN Global Marketplace with the UN Secretariat must ensure that the information and documentation (e.g. financial statements, address, contact name, etc.) provided in connection with their registration are up to date in UNGM.
