DESCRIPTION OF REQUIREMENTS

United Nations Procurement Division intends to publish a solicitation to appoint a suitably-qualified/licensed company for asbestos abatement and the installation of new non-ACM insulation to pipes, tanks, elbows, HVAC equipment, ducts, tee-flanges and the like, inside the Steam Room (Mechanical and Electrical) on the 3rd basement level of the Dag Hammarskjold Library building at UNHQ New York City.

Works under this contract shall include, but not be limited to:

a. Encapsulation and removal of existing insulation containing asbestos and subsequent cleaning of all affected areas.

b. Installation of new non-ACM insulation to pipes, ducts, HVAC equipment, elbows, tee-flanges and the like.

GENERAL REQUIREMENTS

The Contractor will be required to provide appropriate documentation if invited to the later tender process



including, but not limited to the following:

a. A valid New York State Department of Labor Asbestos Handler License issued for the company.

b. Membership of the Abatement Contractors' Respiratory Protection Program as required by OSHA regulations 29 CFR 1926.58(h)3.

c. Evidence that the Abatement Contractor has successfully performed and completed at least three asbestos abatement contracts within the past five years and the Contractor shall be able to use persons who are suitably experienced.

d. Evidence that the Contractor or Subcontractor for insulation has successfully performed and completed at least three pipe insulation projects within the past five years.

e. Evidence that workers and supervisors are certified by NYSDOL and NYCDEP as asbestos handlers and supervisors, along with copies of their respirator fit test and medical forms.

f. Evidence that the Contractor's abatement supervisor is able to submit project records for two comparable abatement projects from the past five years.

g. Contractor/Subcontractor are able to attend pre-bidding site visit prior to the proposal submission date in order to assess site conditions and clarify any issues they may have pertaining to the project requirements.

h. Contractor shall complete this project (asbestos removal and installation of non-ACM insulation) within a maximum of five weeks due to the need to completely shut down an entire system of the building.

SPECIFIC REQUIREMENTS / INFORMATION (IF ANY)

Responding to this request

1.Potential bidders interested in providing the above services are invited to submit an EOI, by completing the accompanying Vendor Response Form either online or manually.

2. Please note that this is not an invitation for submission of proposals. Its purpose is to identify companies that would be interested to participate in the solicitation when issued and if invited to the solicitation by UNPD.

3. Vendor Response Forms must be completed in full. The UN reserves the right to reject Expressions of Interest documents that are incomplete, or are received after the stated deadline.

4. Interested firms must be registered as a vendor with the UN. (If not registered, companies may still respond to the EOI but are strongly recommended to commence the registration process at the United Nations Global Marketplace website (www.ungm.org) identifying 'UN Secretariat' as a selected agency and seeking registration at minimum, Basic Level. The eventual awardee will be expected to meet Level 1 registration status - for Estimated Contract Award \geq US\$ 40,000 and \leq US\$ 500,000.

5. The UN reserves the right to issue the final solicitation documents only to those prospective Vendors that respond to the EOI, and are deemed qualified upon completion of an objective evaluation of their EOI submission.

6. UNPD reserves the right to change or cancel the requirement at any time during the EOI and/or solicitation process. Thus, submitting a reply to this EOI does not automatically guarantee that your company will be considered for receipt of the solicitation when issued.

7. The solicitation and any subsequent commitment to contract will be issued in accordance with UN rules and regulations.

EOI INSTRUCTIONS

1) Registering as a Vendor with the United Nations

Vendors interested in fulfilling the requirement described above must be registered at the UN Global Marketplace (<u>www.ungm.org</u>) with the UN Secretariat in order to be eligible to participate in any solicitation. Prerequisites for Eligibility

In order to be eligible for UN registration, you must declare that:

- A. Your company (as well as any parent, subsidiary or affiliate companies) is not listed in, or associated with a company or individual listed in:
 - I. the Compendium of United Nations Security Council Sanctions Lists (https://www.un.org/sc/suborg/en/sanctions/un-sc-consolidated-list), or
 - II. the IIC Oil for Food List website or, if listed on either, this has been disclosed to the United Nations Procurement Division in writing.
- B. Your company (as well as any parent, subsidiary or affiliate companies) is not currently removed or suspended by the United Nations or any other UN organisation (including the World Bank);
- C. Your company (as well as any parent, subsidiary of affiliate companies) is not under formal investigation, nor have been sanctioned within the preceding three (3) years, by any national authority of a United Nations Member State for engaging or having engaged in proscribed practices, including but not limited to: corruption, fraud, coercion, collusion, obstruction, or any other unethical practice;
