DESCRIPTION OF REQUIREMENTS

The United Nations Office at Nairobi (UNON), on behalf of Climate Technology Centre and Network (CTCN), United Nations Environment Programme (UNEP) invites qualified interested firms to submit Expression of Interest (EOI) to participate in the upcoming solicitation for provision of technical assistance for using simple mobile technologies to scale up digital collection & processing of climate observations for adaptation actions in Malawi.

United Nations Environment Programme (UNEP) on behalf of the Climate Technology Centre and Network (CTCN) requires the services of an institution to deliver the technical assistance. The objective of the technology concept is to strengthen Malawi Department of Climate Change and Meteorological Services and Department of Water Resources's capacity and confidence in using simple mobile technologies and integrating climate data not only in core forecasting and warning functions but also in impact modelling and adaptation by synergistically relating the data to critical time series of climate projections. The technology concept will complement the Department of Climate Change and Meteorological Services, the Department of Water Resources and prior donor efforts, by allowing DCCMS and DWR to extensively test and investigate the use of mobile phone technologies as a solution to collect and digitize water, weather, and



climate observations comprehensively and sustainably.

MUST's Center for Climate Change and Disaster Risk Management (CCC DRM) will provide capacity to DCCMS and DWR on the use of mobile phones to conduct comprehensive and systematic collection of data for application in impact modelling and developing climate futures for purposes of adaptation and disaster risk management. The implementer will provide training on new and improved software and cloud technologies while DCCMS and DWR will integrate the readily available digitized data into its water and climate database management systems.

The databases and software will be used to analyze historical data, proposed comprehensive daily observations and corresponding daily time series of climate projections to derive general and specific regional impact and adaptation models for Malawi.

The proposed technology will help to provide pathways to adapt to climate change and provide practical knowledge and skills to undertake effective data digitization and analysis for impact modelling and adaptation.

Some of the expected activities are;

- Preparing the consultancy work plan, periodical progress reports and final reports.
- Creation of a steering committee, mapping of stakeholders and inception meeting
- Diagnosis of the current systems and equipment available in Malawi to gather climate data
- Assessment of needs and requirements of future users and administrators of the system.
- Evaluation of mobile phone technologies as a solution to collect and digitize weather and climate observations.
- Identify the barriers, the challenges, the opportunities, and strength of the systems in place at DCCMS and DWR to implement such a technological system.
- Design the architecture of the systems.
- Piloting the use of mobile phone technologies as a solution to comprehensively collect and digitize weather and climate observations.
- Designing a financial mechanism that would make this technology concept sustainable in the context of Malawi.
- Train future users, administrators, and beneficiaries of the system

The complete details of the requirement will be provided in the tender documents that will be issued to bidders after this request for EOI is closed.

SPECIFIC REQUIREMENTS / INFORMATION (IF ANY)

The Climate Technology Centre and Network (CTCN) is the operational arm of the United Nations Framework Convention on Climate Change (UNFCCC) Technology Mechanism and co-hosted by the United Nations Environment (UN Environment) in collaboration with the United Nations Industrial Development Organization (UNIDO) and supported by 11 partner institutions with expertise in climate technologies. The mission of the CTCN is to promote accelerated development and transfer of climate technologies at the request of developing countries for energy-efficient, low-carbon and climate-resilient development.

CTCN provides technical assistance to the countries using its own funds (which it receives through voluntary contributions of donor). The requests for Technical Assistance (TA) are submitted to the CTCN by the National Designated Entity (NDE) of the respective country. In this present case the CTCN has developed a response plan and expect to implement the technical assistance on its own funding.

In case you are not a CTCN network member yet, you may apply for this REOI and subsequent solicitation (Request for Proposal), subject to the condition that you submit your completed application for CTCN membership before the proposal submission closing date, which will be communicated in the subsequent Request for Proposal in due course of time. Furthermore, the contract award – should your proposal be



selected – is conditional to your application for CTCN network membership being approved by CTCN management. The requirement to join the CTCN network is only relevant to the main bidder and not subcontractors. Please find more information to join CTCN Network at- <https://www.ctc-n.org/network>

The purpose of this REOI is to identify suitable firms who may be invited for the Request for Proposal after the REOI is closed. In addition to CTCN registration, all applicants should also be registered (free of charge) at United Nations Global Marketplace (www.ungm.org).

EOI INSTRUCTIONS

1) Registering as a Vendor with the United Nations

Vendors interested in fulfilling the requirement described above must be registered at the UN Global Marketplace (www.ungm.org) with the UN Secretariat in order to be eligible to participate in any solicitation. Information on the registration process can be found at <https://www.un.org/Depts/ptd/vendors>.

Prerequisites for Eligibility

In order to be eligible for UN registration, you must declare that:

- A. Your company (as well as any parent, subsidiary or affiliate companies) is not listed in, or associated with a company or individual listed in:
 - I. the Compendium of United Nations Security Council Sanctions Lists (<https://www.un.org/sc/suborg/en/sanctions/un-sc-consolidated-list>), or
 - II. the IIC Oil for Food List website or, if listed on either, this has been disclosed to the United Nations Procurement Division in writing.
- B. Your company (as well as any parent, subsidiary or affiliate companies) is not currently removed or suspended by the United Nations or any other UN organisation (including the World Bank);
- C. Your company (as well as any parent, subsidiary or affiliate companies) is not under formal investigation, nor have been sanctioned within the preceding three (3) years, by any national authority of a United Nations Member State for engaging or having engaged in proscribed practices, including but not limited to: corruption, fraud, coercion, collusion, obstruction, or any other unethical practice;
- D. Your company has not declared bankruptcy, are not involved in bankruptcy or receivership proceedings, and there is no judgment or pending legal action against your company that could impair your company's operations in the foreseeable future;
- E. Your company does not employ, or anticipate employing, any person(s) who is, or has been a UN staff member within the last year, if said UN staff member has or had prior professional dealings with the Vendor in his/her capacity as UN staff member within the last three years of service with the UN (in accordance with UN post-employment restrictions published in ST/SGB/2006/15).
- F. Your company undertakes not to engage in proscribed practices (including but not limited to: corruption, fraud, coercion, collusion, obstruction, or any other unethical practice), with the UN or any other party, and to conduct business in a manner that averts any financial, operational, reputational or other undue risk to the UN.
