## DESCRIPTION OF REQUIREMENTS

1.0 United Nations Assistance Mission for Iraq (UNAMI) on behalf of United Nations Human Settlements Programme (UN-Habitat) Iraq Programme, seeks the interest of qualified contractors to participate in an upcoming tender solicitation for the "Construction of Al Ghadeer Park in Jurf Al Meleh Neighbourhood, Basra Governorate. , Iraq".

2.0 The solicitation will be based on detailed Statement of Works (SoW), Bill of Quantities (BoQ), Technical Specifications, UN General Conditions of Contracts and other related documents which will be provided by UNAMI to all companies who respond to this EOI and qualify for the tender.

3.0 The following activities/works are to be provided by the successful bidder: and include but is not limited to the following:

- Site Work Preparation includes excavation, soil and backfilling, interlock and walkways, Sunshade, Canopy, and equipment.
- Provision of children's playground, tools, and equipment.
- Provision of lightning works for the park.
- Out Gym equipment.
- Electrical works and lightning works for the park.
- Septic tank work.

4.0 For this purpose, UNAMI will undertake a competitive bidding exercise shortly, accordingly would issue a Tender to those companies who would express their interest and provide initial relevant information as to their ability to fulfill UNAMI's requirement.

5.0 In addition, the interested companies are requested to complete their registration at Level-2 on the United Nations Global Marketplace ([www.ungm.org](http://www.ungm.org)).

6.0 Please note the following:

a) This EOI is not an invitation for submission of a bid/proposal.

b) UNAMI reserves the right in selecting the invitees for the competitive bidding based on substantial and proven records of performance in the subject field of activities and mere expressing an interest would not automatically warrant for tender document.

c) UNAMI reserves the right to reject EOIs received after the above deadline.

### 7.0 TECHNICAL PRE-QUALIFICATION CRITERIA:

The interested companies have capability to meet the below technical requirements (7.1 - 7.6):

7.1 Bidders must attend the site visit and pre-bid meeting of the solicitation.

7.2 Bidder must provide a copy of the company's registration certificate in Iraq.

7.3 Bidder must provide a valid business license (in construction) from the Ministry of Planning.

7.4 Bidder must submit latest 3 consecutive years; audited/certified financial statements.

7.5 Bidder must submit a list of minimum 2 completed similar projects performed within the last 5 years.

7.6 Duly completed United Nations Global Marketplace (UNGM) vendor registration formalities at Level-2.

Note 1: Duly completed and signed EOI Pre-Qualification Questionnaire and signed Vendor Response Form (attached).

Note 2: Proof documents must be submitted as part of the company technical bid/proposal upon receipt of the UNAMI tender documents.

## EOI INSTRUCTIONS

### 1) Registering as a Vendor with the United Nations

Vendors interested in fulfilling the requirement described above must be registered at the UN Global Marketplace ([www.ungm.org](http://www.ungm.org)) with the UN Secretariat in order to be eligible to participate in any solicitation. Information on the registration process can be found at <https://www.un.org/Depts/ptd/vendors>.

#### **Prerequisites for Eligibility**

In order to be eligible for UN registration, you must declare that:

- A. Your company (as well as any parent, subsidiary or affiliate companies) is not listed in, or associated with a company or individual listed in:
  - I. the Compendium of United Nations Security Council Sanctions Lists (<https://www.un.org/securitycouncil/content/un-sc-consolidated-list>), or
  - II. the IIC Oil for Food List website or, if listed on either, this has been disclosed to the United Nations Procurement Division in writing.
- B. Your company (as well as any parent, subsidiary or affiliate companies) is not currently removed or suspended by the United Nations or any other UN organisation (including the World Bank);
- C. Your company (as well as any parent, subsidiary or affiliate companies) is not under formal investigation, nor have been sanctioned within the preceding three (3) years, by any national authority of a United Nations Member State for engaging or having engaged in proscribed practices, including but not limited to: corruption, fraud, coercion, collusion, obstruction, or any other unethical practice;
- D. Your company has not declared bankruptcy, are not involved in bankruptcy or receivership proceedings, and there is no judgment or pending legal action against your company that could impair your company's operations in the foreseeable future;
- E. Your company does not employ, or anticipate employing, any person(s) who is, or has been a UN staff member within the last year, if said UN staff member has or had prior professional dealings with the Vendor in his/her capacity as UN staff member within the last three years of service with the UN (in accordance with UN post-employment restrictions published in ST/SGB/2006/15).
- F. Your company undertakes not to engage in proscribed practices (including but not limited to: corruption, fraud, coercion, collusion, obstruction, or any other unethical practice), with the UN or any other party, and to conduct business in a manner that averts any financial, operational, reputational or other undue risk to the UN.
