DESCRIPTION OF REQUIREMENTS

The United Nations Liquidation Entity - MALI intends to dispose by Commercial Sale Steel materials under Customs Authorities in Ayorou (Niger) and in Gao and Labezanga in Mali. The list of items is composed of steel pipes, tubes, palts, bolts, anchors, beams etc.

1. The interested companies are invited to submit their Expression of Interest (EOI) by hand delivery or e-mail as indicated below. The EOI must include, as a minimum, the following information:

a) United Nations Global Market Place (UNGM) Registration: Company should be registered in UN Global Marketplace (UNGM) or should start their registration process immediately if not registered using the link <https://www.ungm.org>. Companies registered at the basic level are strongly advised to upgrade to Level 1

(b) Company's contact details: UNGM Identification Number, company name, address, telephone, physical location and e-mail must be provided in the EOI Form. Failure to provide this information in the EOI Form may result in a rejection of an EOI.

(c) Vendors must be registered in UNGM under the service (UNSPSC No. 80161700) in order to participate in the sales process.

2. This REOI does not constitute a solicitation. The United Nations Liquidation Entity- Mali reserves the right to change or cancel the requirement at any time during the REOI and/or solicitation process. 3. The UNGM Identification Number obtained at the start of the registration process, must be provided to the Procurement officer at the time of submitting the EOI in the completed EOI Form.

Any successful bidder not benefiting from an exemption from the duties and taxes payable on these items by the Government of Mali, will be required to pay these duties and taxes first, and then present the relevant proof of payment to the United Nations Liquidation Entity- Mali before any finalization of its deed of purchase.

EOI INSTRUCTIONS

1) Registering as a Vendor with the United Nations

Vendors interested in fulfilling the requirement described above must be registered at the UN Global Marketplace (www.ungm.org) with the UN Secretariat in order to be eligible to participate in any solicitation. Information on the registration process can be found at <https://www.un.org/Depts/ptd/vendors>.

Prerequisites for Eligibility

In order to be eligible for UN registration, you must declare that:

- A. Your company (as well as any parent, subsidiary or affiliate companies) is not listed in, or associated with a company or individual listed in:
 - I. the Compendium of United Nations Security Council Sanctions Lists (<https://www.un.org/securitycouncil/content/un-sc-consolidated-list>), or
 - II. the IIC Oil for Food List website or, if listed on either, this has been disclosed to the United Nations Procurement Division in writing.
- B. Your company (as well as any parent, subsidiary or affiliate companies) is not currently removed or suspended by the United Nations or any other UN organisation (including the World Bank);
- C. Your company (as well as any parent, subsidiary or affiliate companies) is not under formal investigation, nor have been sanctioned within the preceding three (3) years, by any national authority of a United Nations Member State for engaging or having engaged in proscribed practices, including but not limited to: corruption, fraud, coercion, collusion, obstruction, or any other unethical practice;
- D. Your company has not declared bankruptcy, are not involved in bankruptcy or receivership proceedings, and there is no judgment or pending legal action against your company that could impair your company's operations in the foreseeable future;
- E. Your company does not employ, or anticipate employing, any person(s) who is, or has been a UN staff member within the last year, if said UN staff member has or had prior professional dealings with the Vendor in his/her capacity as UN staff member within the last three years of service with the UN (in accordance with UN post-employment restrictions published in ST/SGB/2006/15).
- F. Your company undertakes not to engage in proscribed practices (including but not limited to: corruption, fraud, coercion, collusion, obstruction, or any other unethical practice), with the UN or any other party, and to conduct business in a manner that averts any financial, operational, reputational or other undue risk to the UN.
