DESCRIPTION OF REQUIREMENTS

1.0 The United Nations Assistance Mission for Iraq (UNAMI) intends to solicit proposals for the Construction of a new water well at UNAMI Regional Office in Erbil, Iraq.

2.0 The solicitation will be based on detailed Statement of Works (SoW), Bill of Quantities (BoQ), Technical Specifications, UN General Conditions of Contracts and other related documents which will be provided by UNAMI to all companies who respond to this EOI and qualify for the tender.

3.0 The scope of work consists as follows:

The work shall consist of but not be limited to the furnishing of all necessary tools, materials, equipment, skilled manpower, transportation, machinery, accessories, and supervision to carry out all works as described below:

1. Civil work
 - 1.1 Earth works
 - 1.2 Concrete work
 - 1.3 Structural Steel Works and Other Metal Works
 - 1.4 Roofing
 - 1.5 Chainlink Fence
2. Electrical works
3. Mechanical works.

4.0 For this purpose, UNAMI will undertake a competitive bidding exercise shortly, accordingly would issue a Request for Quotation (RFQ) to those companies who would express their interest and provide initial relevant information as to their ability to fulfill UNAMI's requirement.

5.0 In addition, the interested companies are requested to complete their registration at Basic Level on the United Nations Global Marketplace (www.ungm.org).

6.0 Please note the following:

- a) This EOI is not an invitation for submission of a quotation/bid/proposal.
- b) UNAMI reserves the right in selecting the invitees for the competitive bidding based on substantial and proven records of performance in the subject field of activities and mere expressing an interest would not automatically warrant for tender document.
- c) UNAMI reserves the right to reject EOIs received after the above deadline.



SPECIFIC REQUIREMENTS / INFORMATION (IF ANY)

7.0 TECHNICAL PRE-QUALIFICATION CRITERIA: The interested companies have capability to meet the below technical requirements:

7.1 Bidder should submit detailed Company profile that indicates its registration in the country of origin (for International Contractor) or Iraqi (for Iraqi Contractor) as Contractor/construction company.

7.2 Submitted proposal should including required supporting documents in English.

7.3 Bidder should submit detailed Submersible Electrical pump, submersible motor, galvanized pipe, chlorination device, electrical cables, panel board, and Automatic pressure switch data/technical specification sheet together with the technical proposal in compliance with UNAMI SOW – (referring to para-G Technical Specifications) or equivalent subject to the standard specification. Note: Failure to submit detailed data/technical specification sheets of one or more of the above seven (7) listed items may result in bid technical disqualification.

7.4 Bidder should accepted the terms of warranty/defects liability as stipulated herein through execution of the Acceptance of Warranty/Defects Liability Statement.

7.5 Bidder should submit a minimum of 3 years of related experience in construction of water wells with provide list of previous projects similar in nature to this proposed project. The minimum required information shall include Project name, location, name of client, client contact details (including mobile phone number, UNAMI may contact the references for verification), contract value including variations, project dates, role of firm, project description, points of similarity with this proposed project, litigation and arbitration history and personnel safety history

7.6 The Bidders must submit Construction Work Schedule indicating the project completion duration of maximum one hundred (100) days.

7.7 Duly completed United Nations Global Marketplace (UNGM) vendor registration formalities at Basic.

Note 1: Duly completed and signed EOI Pre-Qualification Questionnaire and signed Vendor Response Form (attached).

Note 2: Proof documents must be submitted as part of the company technical proposal upon receipt of the UNAMI tender documents (Request for Proposal) and submit your proposal.

EOI INSTRUCTIONS

1) Registering as a Vendor with the United Nations

Vendors interested in fulfilling the requirement described above must be registered at the UN Global Marketplace (www.ungm.org) with the UN Secretariat in order to be eligible to participate in any solicitation. Information on the registration process can be found at <https://www.un.org/Depts/ptd/vendors>.

Prerequisites for Eligibility

In order to be eligible for UN registration, you must declare that:

- A. Your company (as well as any parent, subsidiary or affiliate companies) is not listed in, or associated with a company or individual listed in:
 - I. the Compendium of United Nations Security Council Sanctions Lists (<https://www.un.org/securitycouncil/content/un-sc-consolidated-list>), or
 - II. the IIC Oil for Food List website or, if listed on either, this has been disclosed to the United Nations Procurement Division in writing.
- B. Your company (as well as any parent, subsidiary or affiliate companies) is not currently removed or suspended by the United Nations or any other UN organisation (including the World Bank);
- C. Your company (as well as any parent, subsidiary or affiliate companies) is not under formal investigation, nor have been sanctioned within the preceding three (3) years, by any national authority of a United Nations Member State for engaging or having engaged in proscribed practices, including but not limited to: corruption, fraud, coercion, collusion, obstruction, or any other unethical practice;
- D. Your company has not declared bankruptcy, are not involved in bankruptcy or receivership proceedings, and there is no judgment or pending legal action against your company that could impair your company's operations in the foreseeable future;
