## DESCRIPTION OF REQUIREMENTS

### ENGLISH:

In order to assist Parties to the UNECE Convention on Long-range Transboundary Air Pollution with the ratification process, specifically with the implementation of Best Available Techniques (BATs), and to improve their environmental permitting systems, the UNECE is seeking a consultancy company to carry out capacity building activities.

The purpose of this Request for Expression of Interest (REOI) is to identify potential service providers to be invited to the upcoming Invitation to Bid (ITB) to provide the following services:

- 1- Carry out three (3) feasibility studies in different sectors, two of which in Georgia, and one in Armenia.
- 2- Conduct one (1) study on Best Available Techniques (BAT) incentives on the market and elaborate recommendations for Government action for accelerating introduction of BATs in the industrial sectors in Georgia.
3. Organize one (1) study tour in one of the EU countries for Georgian national experts on air quality management (AQM), BAT, and environmental permits.
4. Develop a training programme on industrial emission control and environmental permitting system, including BAT related regulations and to facilitate an in-person training workshop on BATs in Georgia.
5. Organize a subregional workshop in hybrid mode on BAT implementation and a study tour for countries in Eastern Europe and the Caucasus.

### FRENCH:

Afin d'aider les Parties membres de la Convention de la Commission économique pour l'Europe des Nations -Unies sur la pollution atmosphérique transfrontalière à longue distance dans le processus de ratification, en particulier dans la mise en œuvre des meilleures techniques disponibles (MTD), et l'amélioration de leurs systèmes de permis environnementaux, la Commission économique pour l'europe des Nations -Unies recherche une société de conseil pour mener à bien des activités de renforcement des capacités.

L'objectif de cette demande d'expression d'intérêt (REOI) est d'identifier des prestataires de services potentiels qui seront invités à participer à l'appel d'offres (ITB) pour fournir les services suivants :

- 1- Réaliser trois (3) études de faisabilité dans différents secteurs, dont deux en Géorgie et une en Arménie.
- 2- Effectuer une (1) étude sur les incitations aux meilleures techniques disponibles (MTD) sur le marché et élaborer des recommandations pour l'action gouvernementale afin d'accélérer l'introduction des MTD dans les secteurs de l'Industrie en Géorgie.
3. Organiser un voyage d'étude dans l'un des pays de l'Union Européennesur la gestion de la qualité de l'air (AQM), les MTD et les permis environnementaux.sur la gestion de la qualité de l'air (AQM), les MTD et les permis environnementaux pour les experts nationaux Georgiens
4. Élaborer un programme de formation sur le contrôle des émissions industrielles et le système de permis environnementaux, y compris les réglementations relatives aux MTD et faciliter un atelier de formation en personne sur les MTD en Géorgie.
5. Organiser un atelier sous-régional en mode hybride sur la mise en œuvre des MTD et un voyage d'étude pour les pays d'Europe de l'Est et du Caucase.



## SPECIFIC REQUIREMENTS / INFORMATION (IF ANY)

### ENGLISH:

#### Technical Requirements:

1. Interested bidders must have extensive experience in analyzing requirements of national BAT implementation and international agreements, and in drafting strategic policy recommendations on BAT implementation.
2. Interested bidders must have experience in similar projects in the Eastern Europe and the Caucasus region and in the UNECE region.
3. Interested bidders must have experience in cooperating with the UN system and/or international institutes or other stakeholders.
4. Interested bidders must have experience in working with the UNECE convention and long-range transboundary air pollution, specifically with the technical requirements of the revision of the latest amended protocols (the Protocol to Abate Acidification, Eutrophication and Ground-level Ozone, the Protocol on Heavy Metals, the Protocol on Persistent Organic Pollutants) to the Convention.
5. Interested bidders must have a team of qualified experts with at least seven (7) years of experience in air quality assessment, and management, and collaboration with other international institutes and policymakers.

Vendors who express their interest will be requested to demonstrate how they meet these criteria before being invited to a potential solicitation process.

Further details will be provided as part of the solicitation documents.

### FRENCH:

#### Exigences techniques :

1. Les soumissionnaires intéressés doivent avoir une grande expérience de l'analyse des exigences de la mise en œuvre des MTD au niveau national et des accords internationaux, ainsi que de la rédaction de recommandations stratégiques sur la mise en œuvre des MTD.
2. Les soumissionnaires intéressés doivent avoir une expérience dans des projets similaires dans la région de l'Europe orientale et du Caucase et dans la région de la Commission Economique Européenne des Nations-Unies.
3. Les soumissionnaires intéressés ont l'expérience dans la coopération avec le système des Nations Unies et/ou des instituts internationaux ou d'autres parties concernées.
4. Les soumissionnaires intéressés doivent avoir l'expérience dans le travail du domaine de la convention CEE-ONU et de la pollution atmosphérique transfrontalière à longue distance, notamment avec les exigences techniques de la révision des derniers protocoles modifiés, le Protocole relatif à la réduction de l'acidification, de l'eutrophisation et de l'ozone troposphérique, le Protocole sur les Métaux lourds, Protocole sur les polluants organiques persistants) à la Convention.
5. Les soumissionnaires intéressés doivent disposer d'une équipe d'experts qualifiés possédant au moins sept (7) ans d'expérience dans l'évaluation et la gestion de la qualité de l'air, ainsi que dans la collaboration avec d'autres instituts et décideurs internationaux.

Les fournisseurs qui exprimeront leur intérêt devront démontrer comment ils répondent à ces critères avant d'être invités à un éventuel processus de sollicitation.

## EOI INSTRUCTIONS

### 1) Registering as a Vendor with the United Nations

Vendors interested in fulfilling the requirement described above must be registered at the UN Global Marketplace ([www.ungm.org](http://www.ungm.org)) with the UN Secretariat in order to be eligible to participate in any solicitation. Information on the registration process can be found at <https://www.un.org/Depts/ptd/vendors>.

#### Prerequisites for Eligibility

In order to be eligible for UN registration, you must declare that:

- A. Your company (as well as any parent, subsidiary or affiliate companies) is not listed in, or associated with a company or individual listed in:
  - I. the Compendium of United Nations Security Council Sanctions Lists (<https://www.un.org/securitycouncil/content/un-sc-consolidated-list>), or
  - II. the IIC Oil for Food List website or, if listed on either, this has been disclosed to the United Nations Procurement Division in writing.
- B. Your company (as well as any parent, subsidiary or affiliate companies) is not currently removed or suspended by the United Nations or any other UN organisation (including the World Bank);
- C. Your company (as well as any parent, subsidiary or affiliate companies) is not under formal investigation, nor have been sanctioned within the preceding three (3) years, by any national authority of a United Nations Member State for engaging or having engaged in proscribed practices, including but not limited to: corruption, fraud, coercion, collusion, obstruction, or any other unethical practice;
- D. Your company has not declared bankruptcy, are not involved in bankruptcy or receivership proceedings, and there is no judgment or pending legal action against your company that could impair your company's operations in the foreseeable future;
- E.
