#### **DESCRIPTION OF REQUIREMENTS**

Note: This is a Request for Information pertaining to the subject requirement, so please note that we are not looking to receive just responses to this request without including your relevant product information/technology.

### 1 Background

The United Nations (UN), Department of Field Support (DFS) has a requirement to establish a Global System Contract for the supply of "Waste Management Equipment" to serve different camp sizes of population from, 200 scalable up to 1000 in peacekeeping missions.

"Waste Management Equipment" includes the following:

- a. Pyrolytic Double Chamber Incinerator (three sizes: small/medical unit; medium unit; large unit);
- b. Hydraulic Baler/Compactor;
- c. All-purpose Shredder;
- d. Bulb Crusher:
- e. Concrete Encapsulation Mold;
- f. Large Wheelie Bins;

The engaged Vendor shall be required to design, manufacture, supply, install such equipment and to provide optional services (spare parts, maintenance and operator training).

2 General Features

The required equipment shall meet the following main parameters:

- a. General
- i. Waste material typology to be treated: organic, paper, plastic, metal, glass, and medical wastes;

- ii. Solid Waste production: up to 2 kg/person/day;
- iii. Solutions to serve different camp sizes: population from 200, scalable up to 1000;
- iv. Rapid deployment and easy installation;
- v. Suitable for critical harsh environmental conditions, and for different climate zones (e.g. desert, tropical country, mountain, etc.);
- vi. Suitable to be transported via road, air (via helicopters or air-cargoes, e.g. MI8 or C130) and sea either by 20'ISO shipping containers or by aircraft pallets;
- vii. Easy dismantling and re-packing;
- b. Pyrolytic Double Chamber Incinerator:

- 3. Large Unit: the incinerator must be provided to handle an average waste production of 2,000kg/day and meet the capacity as herein below indicated

- Maximum load capacity: 3,500 kg
- Nominal burning rate: 240 300 kg/hr

v. Resistant to UV, cold, heat and chemicals; vi. The surface easily cleanable (glossy);
