DESCRIPTION OF REQUIREMENTS

The purpose of this Request for Information (RFI) is to provide the United Nations (UN) with a solution and related costs for the implementation of a reverse logistics system for the collection and return to a central location of the non-organic food rations waste, mainly consisting of packaging materials used to pack food, and bulk packaging materials used to protect food items during transportation to the Mission Warehouse and to Contingents sites.

The implementation of a reverse logistics system is aimed to minimize the dispersion of the packaging and bulk packaging material on the Host Country's territory where UN Peacekeeping Missions are located. The packaging and bulk packaging material can either be made of eco-friendly and/or conventional material. Eco-friendly (bulk) packaging material is considered any packaging material that is reusable, recyclable and/or biodegradable, such as carton boxes, plastic containers/boxes, plastic pallets, eco-friendly shrink-wrapping film generated from the transport of food rations from the country of origin to the contingent sites. Since a decrease in waste can be translated into an environmental improvement and considering that an investment in the decreased wastage of (bulk) packaging represents an investment in the environment, bringing with it at the same time the value of corporate responsibility, the Procurement Division and the Rations Unit/Logistics Division would like to draw your experience for the most cost-effective logistics solution.



1. Use of Information

1.1. All costs for preparing a response for the RFI must be covered by the vendor.

1.2. The requested information will only be used by the UN for internal planning purposes and be kept strictly confidential and only authorized personnel will have access to it.

- 1.3. The response to this RFI will not be used to pre-qualify vendors.
- 1.4. The provided information will not be contractually binding to the vendor.

The primary objective of this RFI is to gather information on how vendors would implement the collection and return of packaging materials, and the related costs. Please email your response to the email provided above.

To ensure cost-effective and efficient implementation of a viable logistics solution for the collection and return to a central location of the (bulk) packaging materials used for transporting food rations to Contingent sites, please answer/elaborate on the questions listed below:

Please provide a detailed plan containing the general idea of how you are thinking to accomplish the task of the collection and return to a central location of packaging material used to pack the food, and bulk packaging materials used to protect food during transportation to the Mission Warehouse, and to Contingent sites.

3.2. Please provide cost estimation for the logistics solution you consider implementing using the proposed template.

BACKGROUND

Packaging is ubiquitous in our daily lives and enables the minimization of food waste and overall product breakage with advanced convenience features at low costs. However, the widespread usage of single-use packaging containers has resulted in a heavy burden on the environment, and the management of packaging waste is facing a crisis due to this unresolved challenge.

The UN peacekeeping Missions are also facing this challenge and there is a growing need of finding solutions to reduce the packaging and bulk packaging materials used for the transportation and protection of food to minimize the impact on the environment.

In December 2020 the Office of Supply Chain Management (OSCM) in the Department of Operational Support (DOS), through its Category Management Steering Committee approved the Rations Category Management Strategy, defining a systematic approach to managing food rations and related services with a much greater understanding of client needs.

Among the approved initiatives of the Rations Category Management Strategy, there is a general focus on the environmental protection and reduction of the UN Peacekeeping Missions' footprint, especially through initiatives aimed at reducing food rations generated waste.

The purpose of this RFI is therefore to obtain technical information on logistics solutions for the collection of food packaging materials used to protect food, and bulk packaging material used to protect the rations shipments until their final destination.

This RFI is also intended to facilitate the understanding of the associated implementation costs.

SCOPE

The UN peacekeeping Missions rely on waste disposal by local service providers contracted by the Mission, and Host Country infrastructure, if and when available, while some others have already developed their Waste Management Yard system. These operations, in many cases, take place under adverse conditions in difficult assessable, and remote areas.

Since the food packaging material, as well as the bulk packaging materials used to protect the shipment during transportation, make up a significant part of total waste generated by UN Peacekeeping Missions, it is necessary to explore the possibility of implementing a reverse logistics system capable of collecting this material after its use and transport it to a central location that shall be designated by the Missions.

Ideally, an IT system could also be installed to track the return of (bulk) packaging materials, monitor the overall performance of the process, and provide data for further improvement.

In case Vendors do not have or don't want to install an internal reverse logistics system, they could also rely on a third party (subcontractor) to provide the required services.

An indicative list of steps involved in the delivery process of food rations to the Mission Warehouse and to Contingents sites is as below:

- a. Food Rations manufacturing by the Supplier and packaging for shipment/transportation to the Contractor's Warehouse outside of the Mission
- b. Transportation to the Contractor's Warehouse outside of the Mission
- c. Inbound shipment to the Mission's Warehouse
- d. Delivery to Mission's Warehouse (Packaging and Bulk-packaging materials are generated from the unpacked Food Rations and their repackaging Point 1 of waste generation)
- e. Outbound transportation to Contingent's Sites (Final Delivery Locations) by the rations Contractor
- f. Delivery to Contingent's Sites (Packaging and Bulk-packaging materials are generated from the unpacked Food Rations Point 2 of waste generation)
- g. In some cases, Contingents pick up their rations directly from the Mission's Warehouse through their own trucks

h. <u>Reverse logistics</u>: return of packaging and bulk-packaging materials to a central waste location.

PACKAGING MATERIALS

For clarity, packaging material is the primary packaging in direct contact with the food, and normally consisting of plastic containers/boxes, tins, tissue bags, carton boxes, glass jars, etc.

Bulk packaging material is the vast array of items used to protect the shipment during its transportation, such as insulated boxes, wood/plastic crates, wood/plastic pallets, cushioning, peanuts and foam, bubble wrap, shrink wrap, edge protectors, pallet covers, straps, and similar items.

VOLUME OF OPERATIONS

The configuration of the typical UN Peacekeeping Mission consists of one or more than one Headquarters, where both Civilian and Uniformed Personnel work, and sometimes also live. Usually, the rations warehouse(s) is/are located in or in the vicinity of the Headquarters. As a satellite formation, Regional Forward Locations are dislocated in the rest of the Host Country, even at a considerable distance from the nearest Headquarter. The Forward Locations are mostly populated by Military Personnel.

Currently, there are 10 UN Peacekeeping Operations that provide support to approximately 75,000 personnel. Indicatively is referring that for Fiscal Year (FY) 2020 – 2021, the total volume of Food Rations received by Missions was about 162,000,000 Kg and the volume of business for Food Rations outbound deliveries (from Missions' Warehouse to the Contingents' Sites) was about 30 M USD.

Rations to feed the Military Personnel are transported from the Warehouse(s) to the Regional Forward Locations, i.e. Delivery Points, where troops are located.

Since non-food waste can be generated both at the Warehouses, and mostly at the Delivery Locations, the UN is interested in exploring available options for reverse logistics from the rations Warehouse to the waste treatment location, and from the Delivery Locations to the waste treatment location.

Depending on the Peacekeeping Mission, waste treatment locations can either be offered by the local Government or by the Mission itself. Mission waste treatment locations are either outsourced to UN Contractors or built by the UN (Waste Treatment Yards).

In order to provide the full scenario, based on the different typology of Field Missions, the UN hereby requests to develop a reverse logistics solution based on two UN Missions with different characteristics and volumes of requirements, as per the attached Annex C.

ASSUMPTIONS FOR REVERSE LOGISTICS:

1. Vendor is expected to pick up packing and bulk-packaging waste in the delivery points and return it to the cental waste location which is located in the main WH (or nearby).
