## **DESCRIPTION OF REQUIREMENTS**

The United Nations is seeking information from potential vendors for the provision of consultancy services to support the development of a research on young people with disabilities and their meaningful participation in decision-making spaces, both on a global and on a national level, for the UN Office of the Secretary General's Envoy on Youth (OSGEY).

The United Nations Office of the Secretary General's Envoy on Youth (OSGEY) is the UN Office dedicated to promote and support young people, in all their diversity, for their meaningful participation in decision-making spaces. The Office works to ensure that most left behind youth are recognized and supported in their leadership, including young people with disabilities and young refugees and migrants (just to name a few). OSGEY is part of the Department of Global Communications. In the framework of the UN Youth2030 Strategy, OSGEY has worked together with young people with disabilities, to make not only their needs known and structural barriers they encounter, but also their leadership and agency. As a result, in 2020, OSGEY and partners developed a consultation with young people with disabilities from around the globe, and launched the "Call-to-Action on the Meaningful participation of Young Persons with Disabilties". Furthermore, the current proposal builds on previous "Believe in Better" policy papers led by OSGEY, in the



framework of Youth2030 implementation: these policy papers analyze young people's meaningful participation in the SDG implementation. Lastly, as the Technical Secretariat of the Youth2030 Strategy, OSGEY continuously works with UN Country Teams (UNCTs) to build and strengthen their capacities to implement Youth2030 and work jointly with and for young people. All these efforts and processes are now connected to the Youth2030 Disability Task Team, which aims to promote the rights and meaningful participation of young persons with disabilities at all levels, and strengthen interagency collaboration across the UN (in line with Youth2030 and the UNDIS).

This consultancy will gather data and statistics on young persons with disabilities; map the ways in which youth with disabilities have organized themselves to advocate for their rights; identify existing barriers for their meaningful participation and understand current practices and outcomes of youth involvement in participatory decision-making processes and the extent of the UN System's support to these efforts (both on a global and on a national level -in selected countries-). The consultancy will also identify existing innovative solutions (including tech-based, and from the private sector) aiming to improve young persons with disabilities' inclusion and participation. This consultancy will build the capacity of UNCTs and the UN System as a whole, to work with and for young persons with disabilities and their meaningful participation. The proposed consultancy company will -among others- elaborate at least 2 Guidance documents for UNCTs to better work with youth with disabilities, and implement a series of Webinars with UNCTs and other stakeholders to ensure ownership on this process.

Interested vendors must possess the necessary technical expertise and capacity to provide the required research services, expertise in the subject matter (young people with disabilities), efficient Administrative procedures to ensure the entire process is accessible for people with disabilities (including a final version of the research piece, in Easy-to-read format), as well as knowledge of methodologies to tailor and deliver the Guidance notes and Webinars.

The Request for Information is intended to identify potential vendors with verified experience to supply the requested services.

# **RFI INSTRUCTIONS**

### 1) Registering as a Vendor with the United Nations

Vendors interested in fulfilling the requirement described above must be registered at the UN Global Marketplace (<a href="www.ungm.org">www.ungm.org</a>) with the UN Secretariat in order to be eligible to participate in any solicitation. #### Prerequisites for Eligibility

In order to be eligible for UN registration, you must declare that:

- A. Your company (as well as any parent, subsidiary or affiliate companies) is not listed in, or associated with a company or individual listed in:
  - I. the Compendium of United Nations Security Council Sanctions Lists (https://www.un.org/sc/suborg/en/sanctions/un-sc-consolidated-list), or
  - II. the IIC Oil for Food List website or, if listed on either, this has been disclosed to the United Nations Procurement Division in writing.
- B. Your company (as well as any parent, subsidiary or affiliate companies) is not currently removed or suspended by the United Nations or any other UN organisation (including the World Bank);
- C. Your company (as well as any parent, subsidiary of affiliate companies) is not under formal investigation, nor have been sanctioned within the preceding three (3) years, by any national authority of a United Nations Member State for engaging or having engaged in proscribed practices, including but not limited to: corruption, fraud, coercion, collusion, obstruction, or any other unethical practice;
- D. Your company has not declared bankruptcy, are not involved in bankruptcy or receivership proceedings, and there is no judgment or pending legal action against your company that could impair your company's operations in the foreseeable future:
- E. Your company does not employ, or anticipate employing, any person(s) who is, or has been a UN staff member within the last year, if said UN staff member has or had prior professional dealings with the Vendor in his/her capacity as UN staff member within the last three years of service with the UN (in accordance with UN post-employment restrictions published in ST/SGB/2006/15).
- F. Your company undertakes not to engage in proscribed practices (including but not limited to: corruption, fraud, coercion, collusion, obstruction, or any other unethical practice), with the UN or any other party, and to conduct business in a manner that averts any financial, operational, reputational or other undue risk to the UN.

For Registered Vendors: Vendors already registered at the UN Global Marketplace with the UN Secretariat must ensure that the information and documentation (e.g. financial statements, address, contact name, etc.) provided in connection with their registration are up to date in UNGM. Please verify and ensure that your company is registered under its full legal name.
