DESCRIPTION OF REQUIREMENTS

1. Objectives

The United Nations Secretariat is working toward improving the accessibility of its premises and services and to leverage innovative technologies to achieve this goal. An essential part of this goal is to facilitate the navigation of the buildings on the UNHQ campus for both visitors and staff as well as to provide the individual with relevant information related to their route. An initial proof of concept (POC) will be designed to test the technical feasibility of using wayfinding technologies together with a mobile phone to support navigation inside UN buildings.

2. Scope

The Office of Information and Communications Technology (OICT) will execute a POC to test the use of wayfinding technology together with a mobile phone application to navigate a defined and limited route within the General Assembly building. The way-finding system shall be able to accurately locate a person by locating her/his mobile phone and provide non-visual guidance to a set of possible destinations including nearest exit, nearest bathroom (if the bathrooms are separated by gender it shall navigate to the bathroom of the user's choice), and to a specific conference room or other specific location. The system shall also be able to help a person navigate a preset path such as a path of a tour of the GA building that visitors take and should provide location -based information appropriate to the person's location, such as a pre-recorded audio describing an exhibit.

SPECIFIC REQUIREMENTS / INFORMATION (IF ANY)

Technical approach

The solution that should be provided shall be based operated on a smart phone. The POC should support at least one of the two currently most used mobile operating systems (Google Android and/or Apple iOS) and should support at least two of the three most recent major releases of these operating systems. The solution shall assume the user has a visual disability, including total blindness, but the POC will not be limited to this usage scenario. The solution may include visual guidance for people without visual disability, however, when evaluating the solution this aspect will be of lower priority compared to aspects designed for assisted navigation for persons with visual disabilities. The solution shall not require a major deployment cost to the United Nations such as changes to the building layout, floor or wall alterations or laying extensive cabling or other technical infrastructure. The solution shall not change the visual appearance of the General Assembly building or require covering larger areas of the floor or the walls. Placing small devices on the walls or the floor and limited cabling that can be easily removed without need to extensive repairs is acceptable. The solution shall not require constant Internet access and should be able to operate off-line without degrading in performance. The solution must be stable with a reliability of at least 95% of the time (for the POC). Situations such as application crashing often, loss of location information, low precision and incorrect guidance, slow operation of the application shall be result in an unsuccessful evaluation of the POC.
