DESCRIPTION OF REQUIREMENTS

The purpose of this RFI is to seek additional information on the capabilities of market suppliers and on the market solutions available for the provision of Automated Flight Following System & Portable Aircraft Tracking / Messaging Devices. You are kindly requested to complete the Vendor Response Form and submit the completed Questionnaire to Helen Muchiri at muchiri@un.org and pd-pos-lts-aircharter-unhq@un.org.

The United Nations, in its continuous effort to enhance peace-keeping operations, is expected to conduct a procurement exercise aimed at establishing a contract for the provision of an Automated Flight Following System and Portable Aircraft Tracking/Messaging Devices. This contract is projected to cover an initial period of three (3) years, with the possibility of extending it for two (2) additional years. Such systems are crucial for maintaining real-time automatic geospatial tracking and event logging capabilities, ensuring the safety and efficiency of aviation operations within the UN framework. The procurement process will likely follow stringent guidelines to select a provider that meets the UN's operational requirements and technical standards.

The United Nations Department of Operational Support (DOS) has contractual arrangements with both commercial and military/state-owned air operators for the provision of aviation services over an extended period. The fleet consists of more than 200 civilian and military air assets, including fixed-wing, rotary, and unmanned aircraft, and is mainly operated in Africa, Asia, Middle East, and South America. These air operators are required to have an active compliant aircraft-tracking equipment that transmits real-time automatic geospatial tracking flight data with event logging capabilities to the UN-operated Automated Flight Following system.

SPECIFIC REQUIREMENTS / INFORMATION (IF ANY)

A) The UN is seeking information from a single service provider capable of providing the following services and products intended to track and monitor the location, altitude, speed, and other pertinent data of UN aircraft in real-time for Fleet Awareness and Emergency Response:

1) Automated Flight Following (AFF) Cloud-Based Commercial Off-the-Shelf feature-rich Software as a Service (SaaS), with Help Desk Support, providing automated and manual functionalities, allowing worldwide real-time aircraft tracking, including the start and end times of each flight segment based on block time control parameters, and integrating flight data from diverse sources.

2) Portable Aircraft Tracking & Messaging Devices (PATMD), with airtime plans available as either prepaid tariffs or annual contracts.

B)To respond to this RFI, the below Vendor Response Form and <u>Questionnaire</u> must be completed and returned to the attention of Ms. Helen Muchiri (muchiri@un.org) no later than 30 May 2024.

C)Vendor Registration:

Suppliers are strongly advised that to receive solicitations from the United Nations, one has to be a registered UN vendor at UNGM at Level 2 and approved in the United Nations Secretariat (UNPD) Database.

RFI INSTRUCTIONS

1) Registering as a Vendor with the United Nations

Vendors interested in fulfilling the requirement described above must be registered at the UN Global Marketplace (<u>www.ungm.org</u>) with the UN Secretariat in order to be eligible to participate in any solicitation. Prerequisites for Eligibility

In order to be eligible for UN registration, you must declare that:

- A. Your company (as well as any parent, subsidiary or affiliate companies) is not listed in, or associated with a company or individual listed in:
 - I. the Compendium of United Nations Security Council Sanctions Lists (https://www.un.org/securitycouncil/content/un-sc-consolidated-list), or
 - II. the IIC Oil for Food List website or, if listed on either, this has been disclosed to the United Nations Procurement Division in writing.
- B. Your company (as well as any parent, subsidiary or affiliate companies) is not currently removed or suspended by the United Nations or any other UN organisation (including the World Bank);
- C. Your company (as well as any parent, subsidiary of affiliate companies) is not under formal investigation, nor have been sanctioned within the preceding three (3) years, by any national authority of a United Nations Member State for engaging or having engaged in proscribed practices, including but not limited to: corruption, fraud, coercion, collusion, obstruction, or any other unethical practice;
- D. Your company has not declared bankruptcy, are not involved in bankruptcy or receivership proceedings, and there is no judgment or pending legal action against your company that could impair your company's operations in the foreseeable future;
- E. Your company does not employ, or anticipate employing, any person(s) who is, or has been a UN staff member within the last year, if said UN staff member has or had prior professional dealings with the Vendor in his/her capacity as UN staff member within the last three years of service with the UN (in accordance with UN post-employment restrictions published in ST/SGB/2006/15).
- F. Your company undertakes not to engage in proscribed practices (including but not limited to: corruption, fraud, coercion, collusion, obstruction, or any other unethical practice), with the UN or any other party, and to conduct business in a manner that averts any financial, operational, reputational or other undue risk to the UN.
